Transaction Summary

The transaction closed on Jan 30 2020 and matures in Jun 2032. The pool's current aggregate principal balance is \$1390.8 million compared to \$1394.2 million at close.

The largest loan of the pool (4.3%) is secured by 1633 Broadway - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Allianz Asset Management of America L.P. (12.53%) and WMG Acquisition Corp (11.47%). The second largest loan of the pool (4.3%) is secured by 560 Mission Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 98%. The major tenants included JPMorgan Chase (30.40%) and Ernst & Young (18.37%). The third largest loan of the pool (4.3%) is secured by Starwood Industrial Portfolio - Pooled located in Gary, IN-34.39% Lake County-Kenosha County, IL-WI-1.41% metropolitan area. Occupancy at the subject was 98%. The major tenants included CTDI (6.63%) and The Harvard Drug Store (4.82%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.54% and 27 months as of 03/13/2022, respectively. There are a total of 53 loans and 189 properties in the portfolio. The appraisal LTV was approximately 55.1% compared to the Original loan to value (LTV), which was approximately 55.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.70x. As of 03/13/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution







EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
