Transaction Summary

The transaction closed on Jan 30 2020 and matures in Jun 2032. The pool's current aggregate principal balance is \$1390.5 million compared to \$1394.2 million at close.

The largest loan of the pool (4.3%) is secured by 1633 Broadway - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Allianz Asset Management of America L.P. (12.53%) and WMG Acquisition Corp (11.47%). The second largest loan of the pool (4.3%) is secured by 560 Mission Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 98%. The major tenants included JPMorgan Chase (30.40%) and Ernst & Young (18.37%). The third largest loan of the pool (4.3%) is secured by Starwood Industrial Portfolio - Pooled located in Gary, IN-34.39% Lake County-Kenosha County, IL-WI-1.41% metropolitan area. Occupancy at the subject was 98%. The major tenants included CTDI (6.63%) and The Harvard Drug Store (4.82%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.54% and 28 months as of 04/13/2022, respectively. There are a total of 53 loans and 189 properties in the portfolio. The appraisal LTV was approximately 55.1% compared to the Original loan to value (LTV), which was approximately 55.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.73x. As of 04/13/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.



Type Concentration















EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
