Transaction Summary

The transaction closed on Oct 29 2013 and matures in Oct 2038. The pool's current aggregate principal balance is \$678.3 million compared to \$741.9 million at close.

The largest loan of the pool (15.8%) is secured by Miracle Mile Shops located in metropolitan area. Occupancy at the subject was 98%. The major tenants included V THEATER (8.56%) and SAXE THEATER (4.99%). The second largest loan of the pool (14.7%) is secured by 1615 L Street located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 96%. The major tenants included Pew Center of Research (17.72%) and Cardinia Real Estate (15.27%). The third largest loan of the pool (7.3%) is secured by Briarcliff Office Portfolio located in metropolitan area. Occupancy at the subject was 80%. The major tenants included United States Government (19.43%) and Clark Richardson and Biskup Consulting Engineers Inc. (11.55%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.22% and 87 months as of 12/15/2020, respectively. There are a total of 50 loans and 75 properties in the portfolio. The appraisal LTV was approximately 60.9% compared to the Original loan to value (LTV), which was approximately 63.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.68x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.






Local Distribution





Most recent net operating income debt yield ranged from 4% to 27% with a weighted average NOI debt yield of 13.1%. NOI debt yield ranged from 4% to 27%. NCF DSCR ranged from 0.0x to 3.0x. There were 1 assets (1.2% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (7.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 16 assets (28.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (37.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (18.9% of total balance) with NCF DSCR between 2.0x and 2.5x and 3 assets (6.7% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.7x.







DSCRs ranged from 0.5x to 4.0x.There are 1 assets (1.2% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (33.4% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (36.9% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (21.3% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (2.9% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (4.2% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.8x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
