Transaction Summary

The transaction closed on Oct 29 2013 and matures in Aug 2035. The pool's current aggregate principal balance is \$643.0 million compared to \$720.1 million at close.

The largest loan of the pool (16.3%) is secured by Miracle Mile Shops located in metropolitan area. Occupancy at the subject was 90%. The major tenants included V Theater (8.56%) and Victoria's Secret (4.65%). The second largest loan of the pool (15.6%) is secured by 1615 L Street located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 78%. The major tenants included Pew Center of Research (17.72%) and Independent Community Bankers of America (9.42%). The third largest loan of the pool (7.4%) is secured by Briarcliff Office Portfolio located in metropolitan area. Occupancy at the subject was 81%. The major tenants included United States Government (20.15%) and Clark Richardson and Biskup Consulting Engineers Inc. (12.27%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.20% and 102 months as of 03/15/2022, respectively. There are a total of 48 loans and 72 properties in the portfolio. The appraisal LTV was approximately 57.6% compared to the Original loan to value (LTV), which was approximately 63.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.30x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.

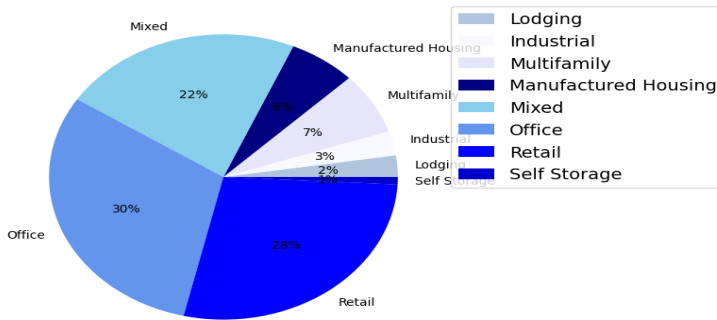

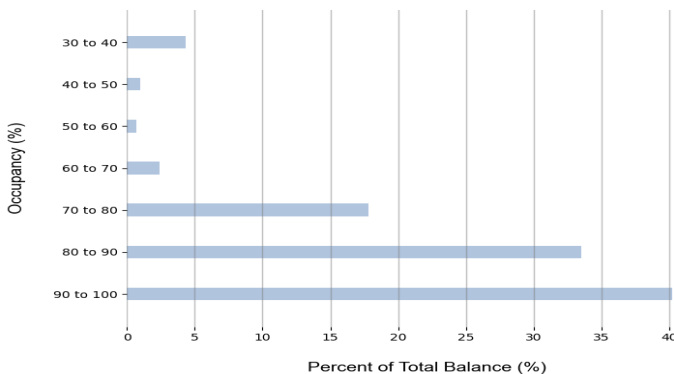

Occupancy Distribution (%)

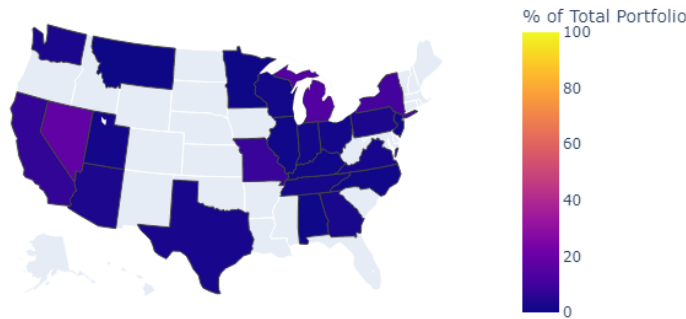

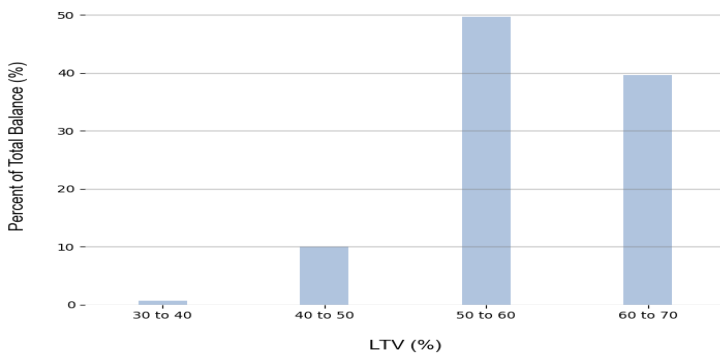
Local Distribution



Among assets in the portfolio, there are 3 properties (18% of total balance) located in Nevada, 1 property (16% of total balance) in Washington DC, 13 properties (14% of total balance) in Michigan, 4 properties (11% of total balance) in New York, 7 properties (8% of total balance) in Missouri, 7 properties (7% of total balance) in California, 3 properties (3% of total balance) in Arizona and 2 properties (3% of total balance) in Pennsylvania. 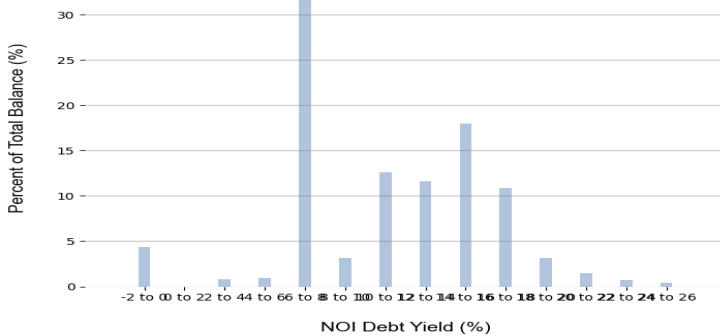

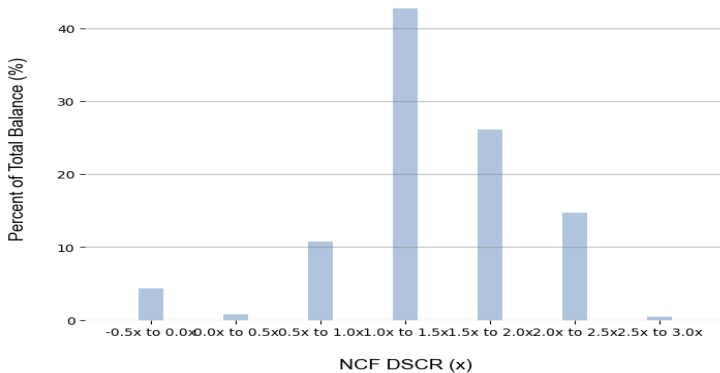
NOI Debt Yield (%)

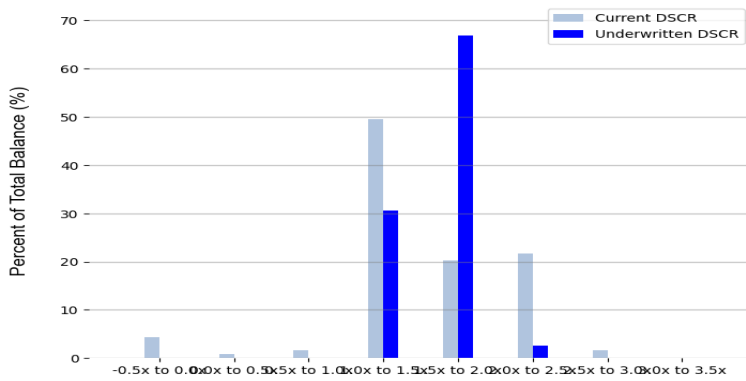
Net Cash Flow DSCR (x)

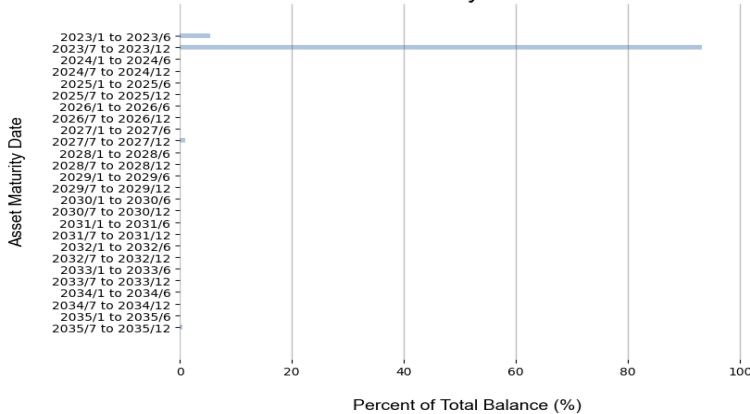
DSCR Distribution (x)

There are 1 assets (4.3% of total balance) with DSCR between -0.5x and 0.0x, 1 assets (0.8% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.7% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (49.6% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (20.2% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (21.7% of total balance) with DSCR between 2.0x and 2.5x and 3 assets (1.7% of total balance) with DSCR between 2.5x and 3.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
