## Transaction Summary

The transaction closed on Dec 30 2013 and matures in Jan 2024. The pool's current aggregate principal balance is \$778.6 million compared to \$861.3 million at close.

The largest loan of the pool (13.5%) is secured by Jordan Creek Town Center located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Century Theaters (13.90%) and Barnes & Noble (5.96%). The second largest loan of the pool (10.7%) is secured by The Aire located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 86%. The major tenants included Mandell School (0.00%) and Flywheel Sports, Inc. (0.00%). The third largest loan of the pool (8.7%) is secured by Wildwood Center located in metropolitan area. Occupancy at the subject was 84%. The major tenants included MANHATTAN ASSOCIATES IN (32.07%) and DS SERVICES OF AMERICA I (8.42%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.91% and 83 months as of 10/15/2020, respectively. There are a total of 51 loans and 53 properties in the portfolio. The appraisal LTV was approximately 58.9% compared to the Original loan to value (LTV), which was approximately 64.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.52x. As of 10/15/2020, 0.88% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

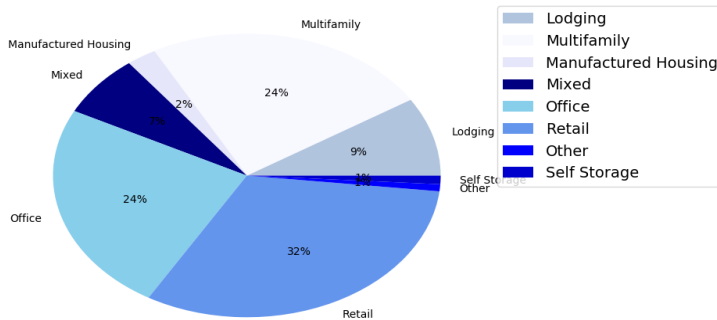

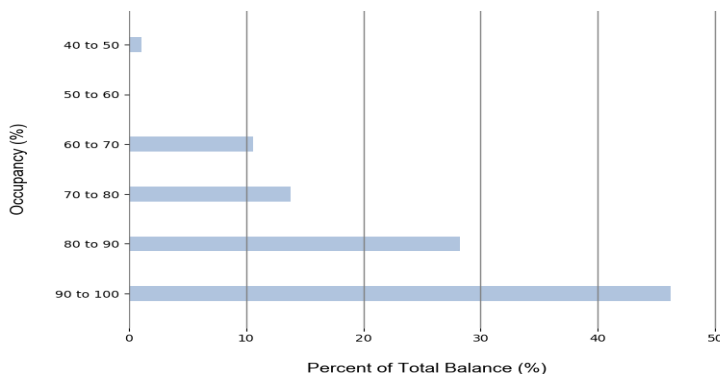

Occupancy Distribution (%)

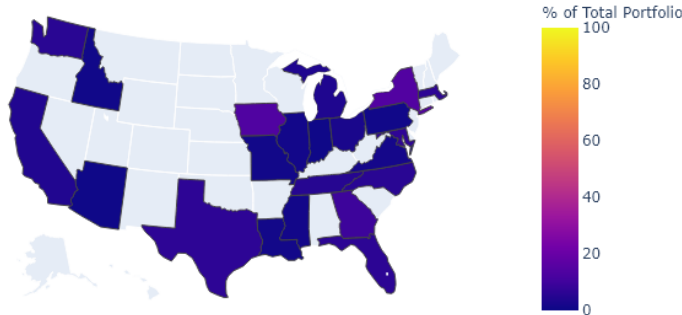

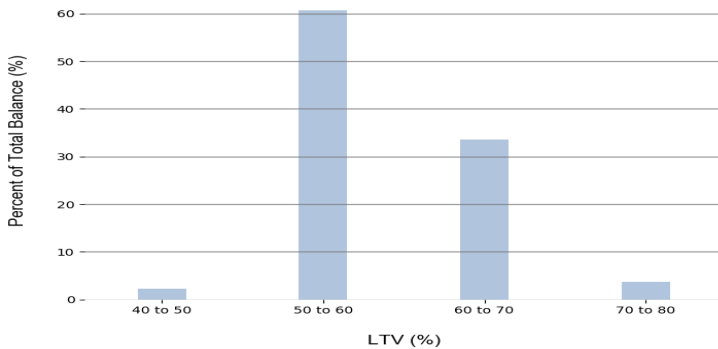
Local Distribution



Among assets in the portfolio, there are 4 properties (14% of total balance) located in New York, 1 property (14% of total balance) in Iowa, 2 properties (9% of total balance) in Georgia, 2 properties (7% of total balance) in Maryland, 4 properties (6% of total balance) in Texas, 2 properties (6% of total balance) in Massachusetts, 6 properties (6% of total balance) in Florida and 1 property (6% of total balance) in Washington. 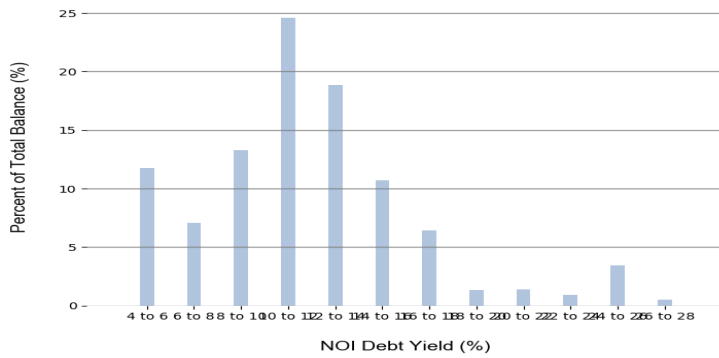

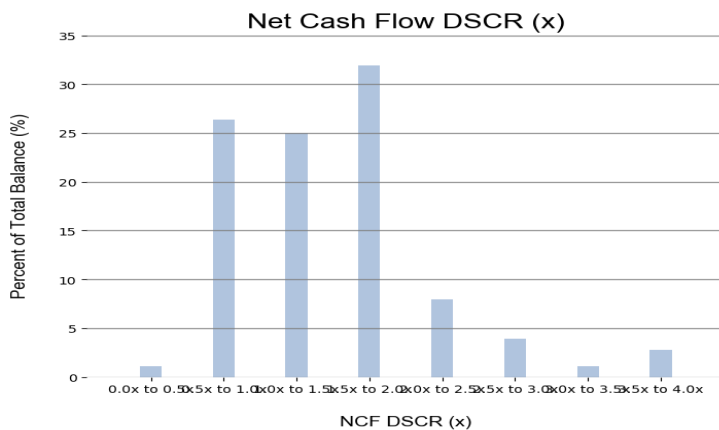

Most recent net operating income debt yield ranged from 4% to 27% with a weighted average NOI debt yield of 11.9%. NOI debt yield ranged from 4% to 27%. There were 2 assets (12% of total balance) with NOI debt yield between 4% and 6%, 2 assets (7% of total balance) with NOI debt yield between 6% and 8%, 6 assets (13% of total balance) with NOI debt yield between 8% and 10%, 9 assets (25% of total balance) with NOI debt yield between 10% and 12%, 12 assets (19% of total balance) with NOI debt yield between 12% and 14%, 6 assets (11% of total balance) with NOI debt yield between 14% and 16%, 6 assets (6% of total balance) with NOI debt yield between 16% and 18%, 2 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 20% and 22%, 1 assets (1% of total balance) with NOI debt yield between 22% and 24%, 3 assets (3% of total balance) with NOI debt yield between 24% and 26% and 1 assets (0% of total balance) with NOI debt yield between 26% and 28%.

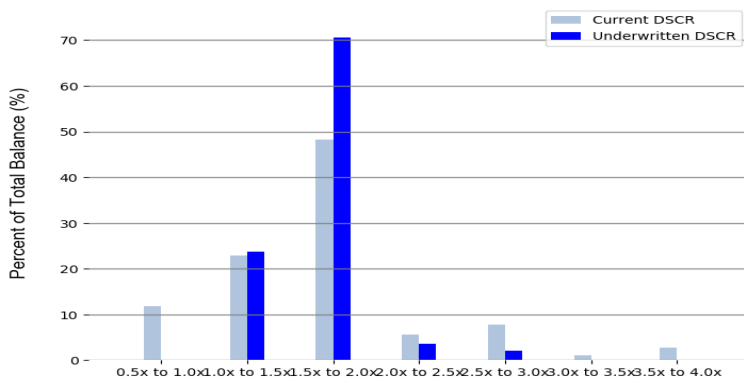


NCF DSCR ranged from 0.0x to 4.0x. There were 1 assets (1.1% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (26.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 14 assets (24.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 19 assets (32.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (7.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (3.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.1% of total balance) with NCF DSCR between 3.0x and 3.5x and 3 assets (2.8% of total balance) with NCF DSCR between 3.5x and 4.0x. 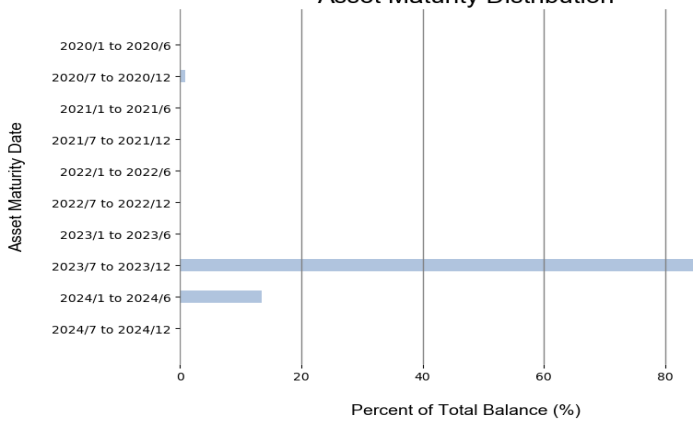
**DSCR Distribution (x)**



DSCRs ranged from 0.5x to 4.0x. There are 2 assets (11.7% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (22.8% of total balance) with DSCR between 1.0x and 1.5x, 24 assets (48.2% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (5.5% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (7.8% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.1% of total balance) with DSCR between 3.0x and 3.5x and 3 assets (2.8% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.7x.

There are 1 assets (0.9% of total balance) that have maturity dates between 2020/7 and 2020/12, 49 assets (85.6% of total balance) that have maturity dates between 2023/7 and 2023/12 and 1 assets (13.5% of total balance) that have maturity dates between 2024/1 and 2024/6.

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

### 2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1a and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v1.

### 3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

### 4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
