Transaction Summary

The transaction closed on Dec 30 2013 and matures in Jan 2024. The pool's current aggregate principal balance is \$775.6 million compared to \$861.3 million at close.

The largest loan of the pool (13.5%) is secured by Jordan Creek Town Center located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Century Theaters (13.90%) and Barnes & Noble (5.96%). The second largest loan of the pool (10.7%) is secured by The Aire located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 86%. The major tenants included Mandell School (0.00%) and Flywheel Sports, Inc. (0.00%). The third largest loan of the pool (8.7%) is secured by Wildwood Center located in metropolitan area. Occupancy at the subject was 84%. The major tenants included MANHATTAN ASSOCIATES IN (32.07%) and DS SERVICES OF AMERICA I (8.42%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.91% and 85 months as of 12/15/2020, respectively. There are a total of 51 loans and 53 properties in the portfolio. The appraisal LTV was approximately 58.7% compared to the Original loan to value (LTV), which was approximately 64.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.52x. As of 12/15/2020, 0.86% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

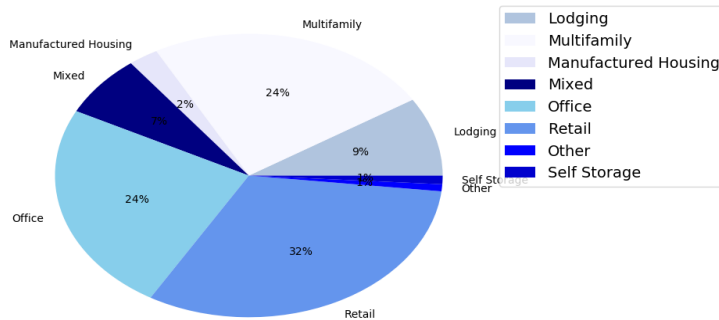

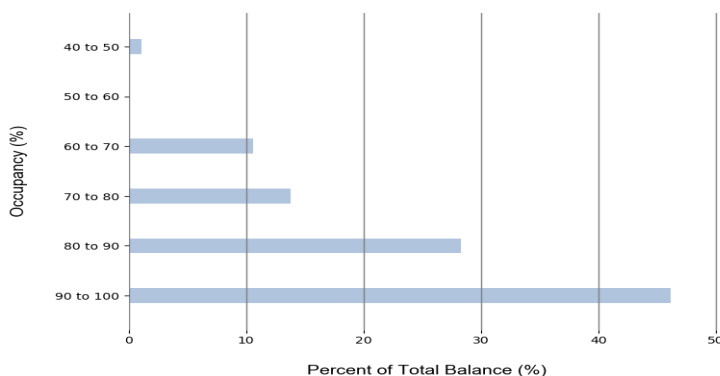

Occupancy Distribution (%)

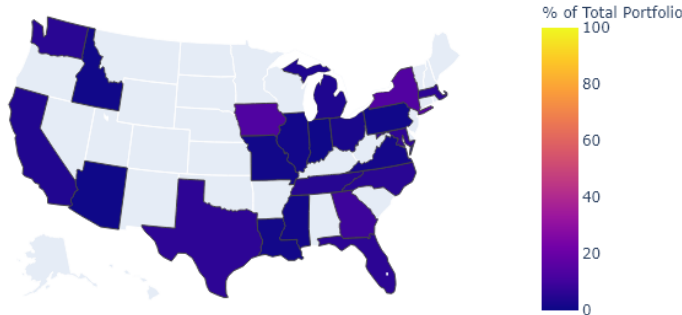

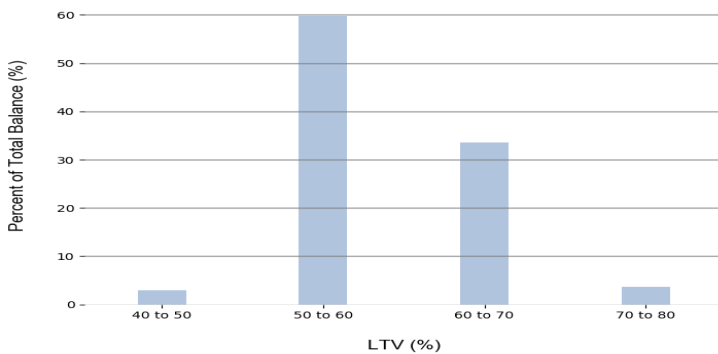
Local Distribution

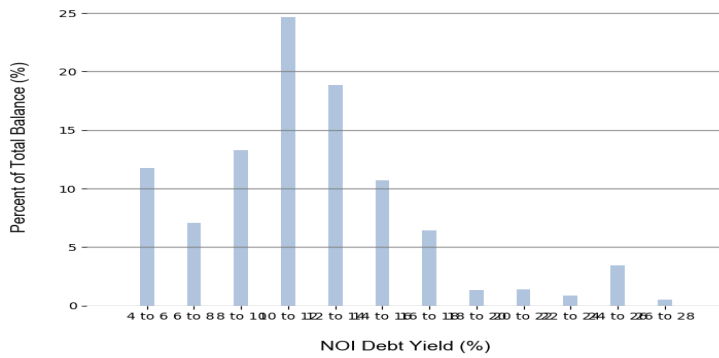

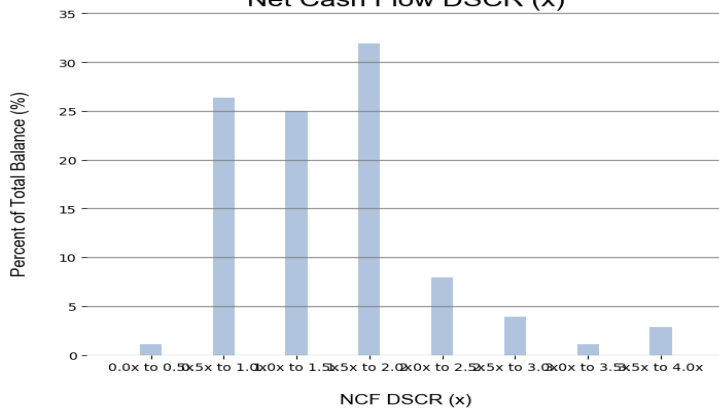
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 27% with a weighted average NOI debt yield of 12.0%. NOI debt yield ranged from 4% to 27%. Net Cash Flow DSCR (x)

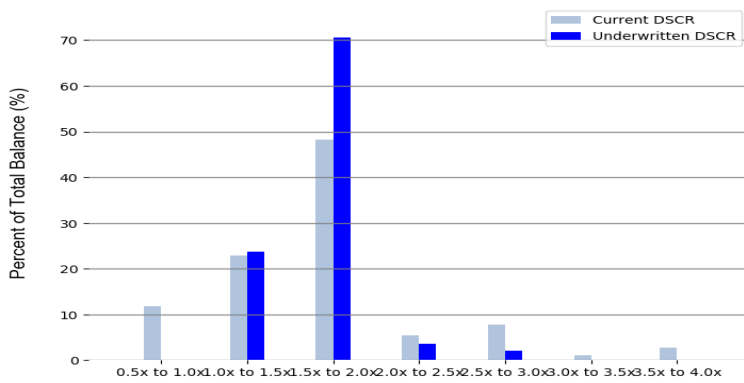

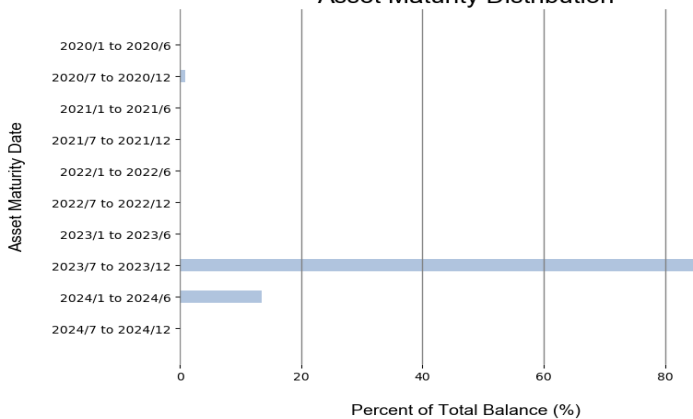
DSCR Distribution (x)



DSCRs ranged from 0.5x to 4.0x. There are 2 assets (11.7% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (22.8% of total balance) with DSCR between 1.0x and 1.5x, 24 assets (48.2% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (5.5% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (7.8% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.1% of total balance) with DSCR between 3.0x and 3.5x and 3 assets (2.8% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.7x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
