# **Transaction Summary**

The transaction closed on Dec 30 2013 and matures in Jan 2024. The pool's current aggregate principal balance is \$741.9 million compared to \$850.1 million at close.

The largest loan of the pool (13.7%) is secured by Jordan Creek Town Center located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Century Theaters (13.90%) and Barnes & Noble (5.96%). The second largest loan of the pool (10.8%) is secured by The Aire located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Mandell School (0.00%) and Flywheel Sports, Inc. (0.00%). The third largest loan of the pool (8.8%) is secured by Wildwood Center located in metropolitan area. Occupancy at the subject was 83%. The major tenants included MANHATTAN ASSOCIATES IN (32.07%) and DS SERVICES OFAMERICA I (8.42%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.90% and 101 months as of 04/15/2022, respectively. There are a total of 50 loans and 52 properties in the portfolio. The appraisal LTV was approximately 57.3% compared to the Original loan to value (LTV), which was approximately 63.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.37x. As of 04/15/2022, 0.67% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.








#### Local Distribution









# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
