## Transaction Summary

The transaction closed on Feb 28 2014 and matures in Feb 2029. The pool's current aggregate principal balance is \$727.6 million compared to \$802.5 million at close.

The largest loan of the pool (13.7%) is secured by Miami International Mall located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 91%. The major tenants included Macy's (112.41%) and Sears (63.42%). The second largest loan of the pool (12.0%) is secured by Jordan Creek Town Center located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Dillard's (39.31%) and Younker's (30.22%). The third largest loan of the pool (10.3%) is secured by Marriott Anaheim located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 83%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.81% and 83 months as of 12/15/2020, respectively. There are a total of 40 loans and 59 properties in the portfolio. The appraisal LTV was approximately 56.8% compared to the Original loan to value (LTV), which was approximately 61.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.90x. As of 12/15/2020, 3.23% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

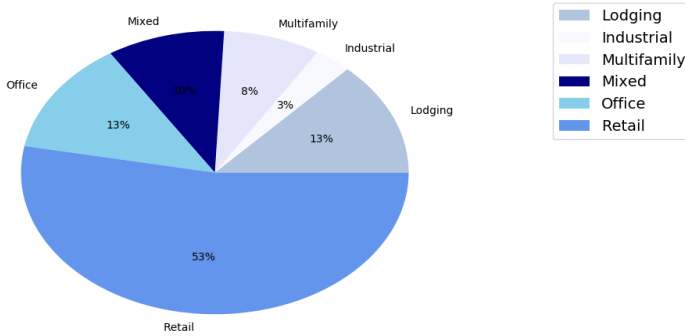

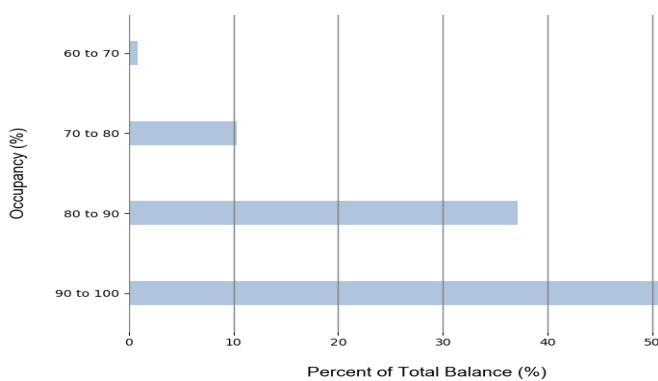

Occupancy Distribution (%)

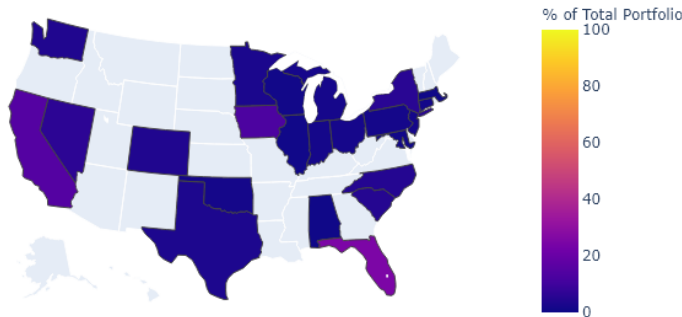

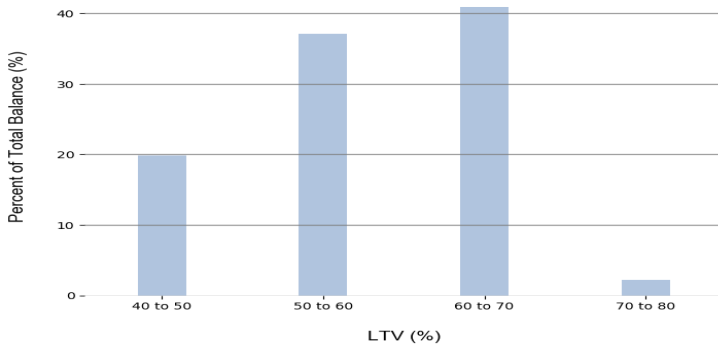
Local Distribution

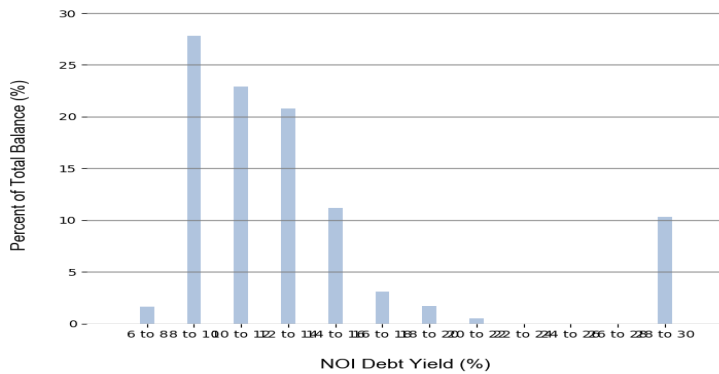

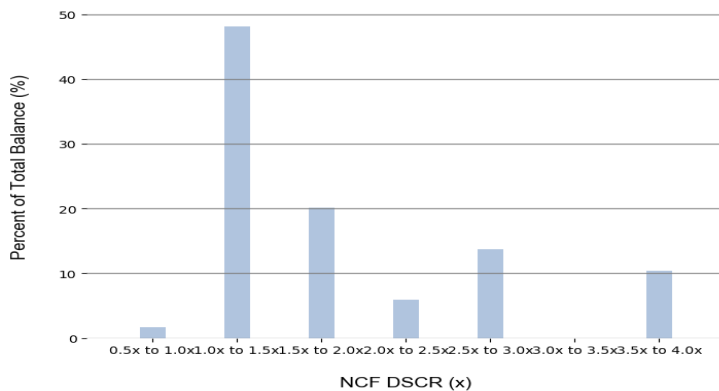
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 29% with a weighted average NOI debt yield of 13.5%. NOI debt yield ranged from 6% to 29%. Net Cash Flow DSCR (x)

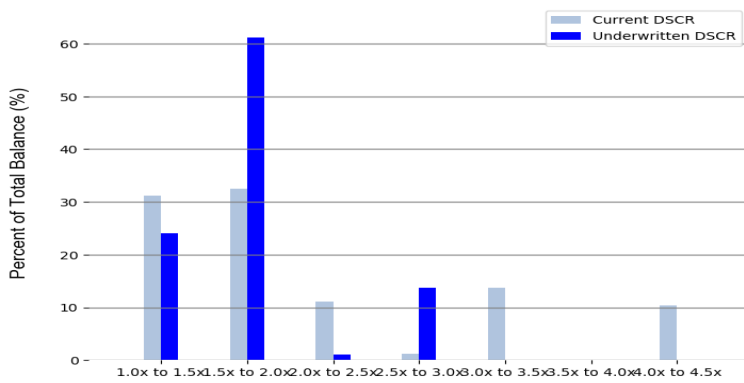

There were 1 assets (1.6% of total balance) with NCF DSCR between 0.5x and 1.0x, 17 assets (48.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (20.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (6.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (13.7% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (10.3% of total balance) with NCF DSCR between 3.5x and 4.0x. 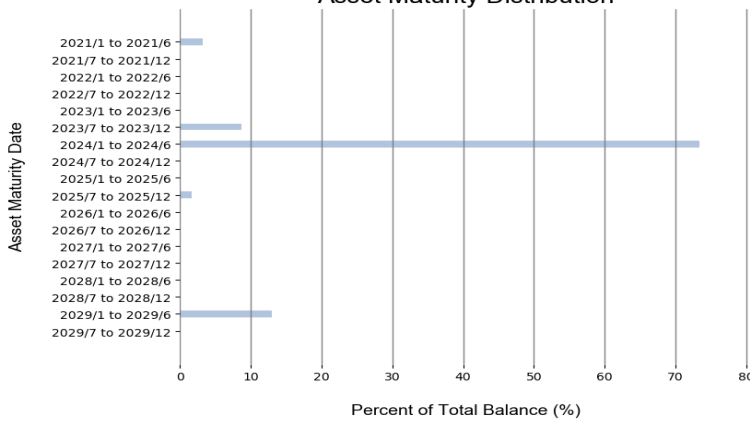
**DSCR Distribution (x)**



DSCRs ranged from 1.0x to 4.5x. There are 12 assets (31.2% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (32.5% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (11.1% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (1.2% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (13.7% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (10.3% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.1x.

There are 2 assets (3.2% of total balance) that have maturity dates between 2021/1 and 2021/6, 2 assets (8.8% of total balance) that have maturity dates between 2023/7 and 2023/12, 33 assets (73.3% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (1.7% of total balance) that have maturity dates between 2025/7 and 2025/12 and 2 assets (13.0% of total balance) that have maturity dates between 2029/1 and 2029/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
