Transaction Summary

The transaction closed on Feb 28 2014 and matures in Feb 2029. The pool's current aggregate principal balance is \$660.8 million compared to \$751.2 million at close.

The largest loan of the pool (15.1%) is secured by Miami International Mall located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 83%. The major tenants included H&M (7.42%) and Old Navy (5.51%). The second largest loan of the pool (12.8%) is secured by Jordan Creek Town Center located in metropolitan area. Occupancy at the subject was 90%. The major tenants included Dillard's (39.31%) and SCHEELS (24.26%). The third largest loan of the pool (11.1%) is secured by Marriott Anaheim located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 23%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.81% and 99 months as of 04/15/2022, respectively. There are a total of 36 loans and 53 properties in the portfolio. The appraisal LTV was approximately 61.4% compared to the Original loan to value (LTV), which was approximately 60.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.34x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 78%.






Local Distribution





Most recent net operating income debt yield ranged from 0% to 25% with a weighted average NOI debt yield of 10.0%. NOI debt yield ranged from 0% to 25%. There were 1 assets (11% of total balance) with NOI debt yield between 0% and 2%, 1 assets (6% of total balance) with NOI debt yield between 2% and 4%, 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 1 assets (3% of total balance) with NOI debt yield between 6% and 8%, 7 assets (14% of total balance) with NOI debt yield between 8% and $10\%,\,5$ assets (23% of total balance) with NOI debt yield between 10% and 12%, 7 assets (27% of total balance) with NOI debt yield between 12% and 14%, 5 assets (8% of total balance) with NOI debt yield between 14% and 16%, 3 assets (3% of total balance) with NOI debt yield between 16% and 18%, 4 assets (3% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 24% and 26%

NCF DSCR ranged from 0.0x to 3.0x. There were 3 assets (18.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (4.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (39.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 9 assets (13.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (9.0% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (15.1% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.3x.







DSCRs ranged from 0.0x to 3.0x.There are 2 assets (17.6% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (2.6% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (25.2% of total balance) with DSCR between 1.0x and 1.5x, 10 assets (29.4% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (8.8% of total balance) with DSCR between 2.0x and 2.5x and 2 assets (16.4% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.4x.

There are 2 assets (60.8% of total balance) that have maturity dates between 2023/7 and 2023/12, 31 assets (495.8% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (11.9% of total balance) that have maturity dates between 2025/7 and 2025/12 and 2 assets (92.3% of total balance) that have maturity dates between 2029/1 and 2029/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
