Transaction Summary

The transaction closed on May 21 2014 and matures in Apr 2034. The pool's current aggregate principal balance is \$869.9 million compared to \$935.0 million at close.

The largest loan of the pool (14.4%) is secured by The Outlets at Orange located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Dave & Buster's (7.36%) and Vans Skate Park (5.38%). The second largest loan of the pool (10.3%) is secured by Arundel Mills & Marketplace located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Maryland Live! Casino (ground lease) (15.75%) and Bass Pro Shops (7.71%). The third largest loan of the pool (8.0%) is secured by 55 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included COWORKERS 55 BROADWAY LLC (12.72%) and Abseven stars (5.91%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.70% and 79 months as of 10/15/2020, respectively. There are a total of 50 loans and 72 properties in the portfolio. The appraisal LTV was approximately 57.1% compared to the Original loan to value (LTV), which was approximately 61.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.18x. As of 10/15/2020, 12.98% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution









There are 1 assets (2.5% of total balance) with DSCR between 0.0x and 0.5x, 9 assets (19.4% of total balance) with DSCR between 1.0x and 1.5x, 19 assets (33.3% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (10.0% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (3.9% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (10.3% of total balance) with DSCR between 3.0x and 3.5x. 1 assets (14.4% of total balance) with DSCR between 3.5x and 4.0x, 2 assets (3.6% of total balance) with DSCR between 4.0x and 4.5x and 2 assets (2.7% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
