## **Transaction Summary**

The transaction closed on May 21 2014 and matures in Apr 2034. The pool's current aggregate principal balance is \$867.9 million compared to \$935.0 million at close.

The largest loan of the pool (14.4%) is secured by The Outlets at Orange located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Dave & Buster's (7.36%) and Vans Skate Park (5.38%). The second largest loan of the pool (10.3%) is secured by Arundel Mills & Marketplace located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Maryland Live! Casino (ground lease) (15.75%) and Bass Pro Shops (7.71%). The third largest loan of the pool (8.1%) is secured by 55 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included COWORKERS 55 BROADWAY LLC (12.72%) and Abseven stars (5.91%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.70% and 81 months as of 12/15/2020, respectively. There are a total of 50 loans and 72 properties in the portfolio. The appraisal LTV was approximately 57.4% compared to the Original loan to value (LTV), which was approximately 61.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.19x. As of 12/15/2020, 12.99% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.



**Type Concentration** 











# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
