## Transaction Summary

The transaction closed on Aug 22 2014 and matures in Aug 2034. The pool's current aggregate principal balance is \$961.4 million compared to \$1056.0 million at close.

The largest loan of the pool (9.0%) is secured by Queens Atrium located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included City of New York (30.49%) and City Of New York (25.08%). The second largest loan of the pool (7.9%) is secured by One Met Center located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included The Hudson Group (22.13%) and Aegis Insurance Services Inc (16.44%). The third largest loan of the pool (7.7%) is secured by Las Catalinas Mall located in metropolitan area. Occupancy at the subject was 51%. The major tenants included Forever 21 (3.85%) and Old Navy (3.58%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.57% and 92 months as of 03/15/2022, respectively. There are a total of 69 loans and 119 properties in the portfolio. The appraisal LTV was approximately 78.9% compared to the Original loan to value (LTV), which was approximately 68.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.40x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 77%.

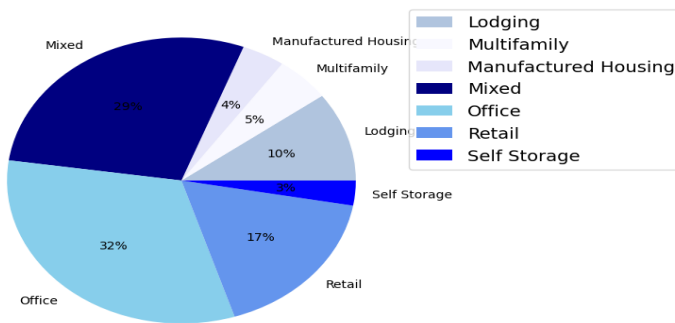

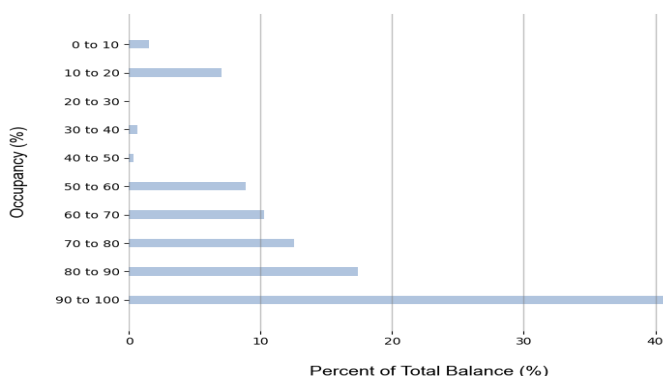

### Occupancy Distribution (%)



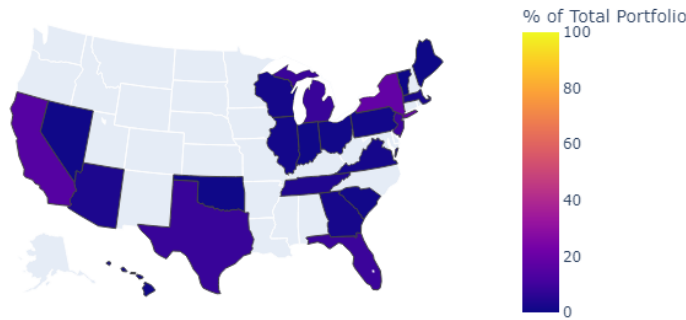

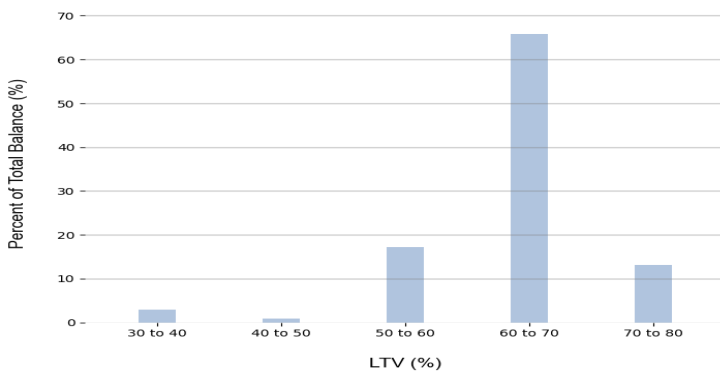
Local Distribution



Among assets in the portfolio, there are 12 properties (18% of total balance) located in New York, 11 properties (15% of total balance) in California, 2 properties (9% of total balance) in New Jersey, 6 properties (9% of total balance) in Florida, 27 properties (9% of total balance) in Michigan, 13 properties (8% of total balance) in Texas and 1 property (7% of total balance) in nan. 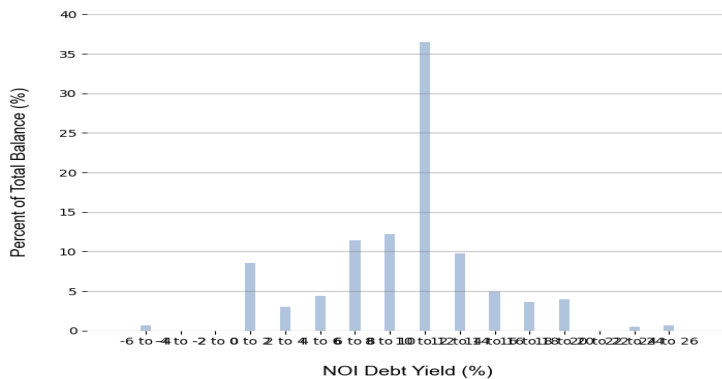

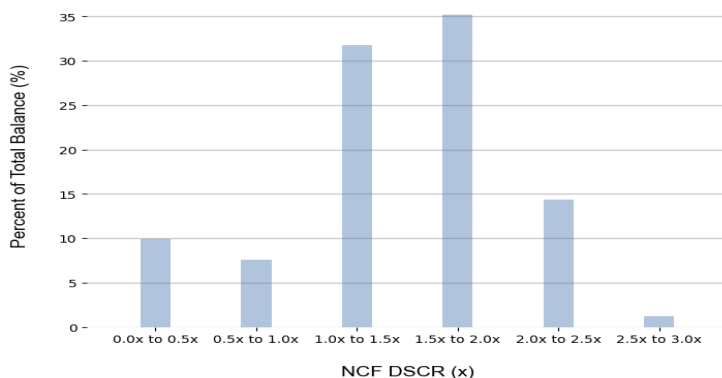
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from -6% to 25% with a weighted average NOI debt yield of 10.0%. NOI debt yield ranged from -6% to 25%. 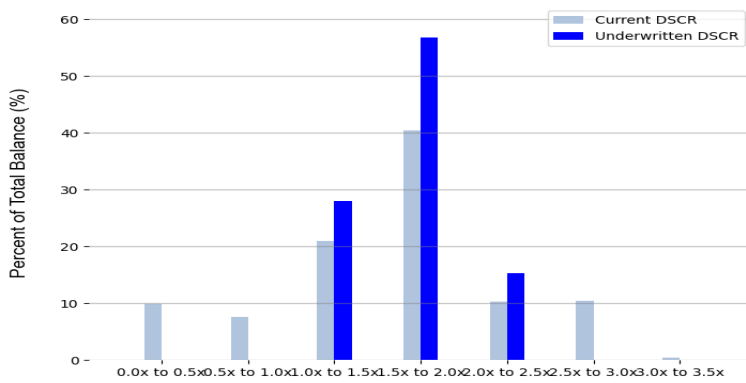
Net Cash Flow DSCR (x)

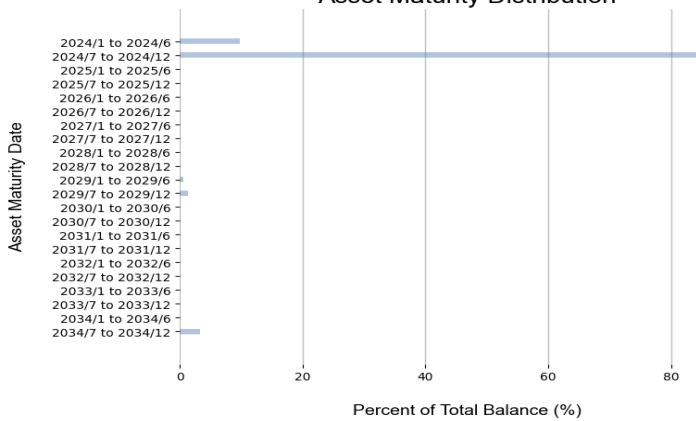
**DSCR Distribution (x)**

There are 4 assets (9.9% of total balance) with DSCR between 0.0x and 0.5x, 6 assets (7.5% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (21.0% of total balance) with DSCR between 1.0x and 1.5x, 27 assets (40.4% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (10.2% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (10.4% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (0.5% of total balance) with DSCR between 3.0x and 3.5x. There are 13 assets (94.3% of total balance) that have maturity dates between 2024/1 and 2024/6, 51 assets (817.1% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (6.2% of total balance) that have maturity dates between 2029/1 and 2029/6, 2 assets (12.7% of total balance) that have maturity dates between 2029/7 and 2029/12 and 2 assets (31.1% of total balance) that have maturity dates between 2034/7 and 2034/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
