# **Transaction Summary**

The transaction closed on Sep 30 2014 and matures in Sep 2035. The pool's current aggregate principal balance is \$1035.4 million compared to \$1089.1 million at close.

The largest loan of the pool (10.1%) is secured by 17 State Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included IP Soft Inc. (22.40%) and Alphadyne Asset Management LLC (7.83%). The second largest loan of the pool (9.7%) is secured by Columbus Square Portfolio located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Quick Park Garage LLC (21.94%) and Whole Foods Market (12.64%). The third largest loan of the pool (7.7%) is secured by Grapevine Mills located in Fort Worth-Arlington, TX metropolitan area. Occupancy at the subject was 94%. The major tenants included Fieldhouse USA (7.94%) and Burlington Capital Group (7.48%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.49% and 74 months as of 10/15/2020, respectively. There are a total of 54 loans and 103 properties in the portfolio. The appraisal LTV was approximately 66.1% compared to the Original loan to value (LTV), which was approximately 67.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.02x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.





#### Occupancy Distribution (%)









Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 10.9%. NOI debt yield ranged from 4% to 25%. There were 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 6 assets (20% of total balance) with NOI debt yield between 6% and 8%, 11 assets (29% of total balance) with NOI debt yield between 8% and 10%, 14 assets (25% of total balance) with NOI debt yield between 10% and 12%, 5 assets (2% of total balance) with NOI debt yield between 12% and 14%, 5 assets (12% of total balance) with NOI debt yield between 14% and 16%, 6 assets (6% of total balance) with NOI debt yield between 16% and 18%, 2 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (0% of total balance) with NOI debt yield between 20% and 22%, 1 assets (1% of total balance) with NOI debt yield between 22% and 24% and 2 assets (3% of total balance) with NOI debt yield between 24% and 26%.

There were 2 assets (1.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 14 assets (29.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 23 assets (36.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (8.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (3.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (12.8% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (7.7% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 2.0x.







# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
