## Transaction Summary

The transaction closed on Oct 22 2014 and matures in Nov 2044. The pool's current aggregate principal balance is \$1079.2 million compared to \$1125.9 million at close.

The largest loan of the pool (10.7%) is secured by Grapevine Mills located in Fort Worth-Arlington, TX metropolitan area. Occupancy at the subject was 94%. The major tenants included Fieldhouse USA (7.94%) and Burlington Capital Group (7.48%). The second largest loan of the pool (10.7%) is secured by The Mall of Victor Valley located in metropolitan area. Occupancy at the subject was 99%. The major tenants included JC Penney (19.22%) and Sears (16.38%). The third largest loan of the pool (8.6%) is secured by Columbus Square Portfolio located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Quick Park Garage LLC (21.94%) and Whole Foods Market (12.64%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.42% and 73 months as of 10/15/2020, respectively. There are a total of 44 loans and 52 properties in the portfolio. The appraisal LTV was approximately 67.0% compared to the Original loan to value (LTV), which was approximately 63.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.00x. As of 10/15/2020, 6.28% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

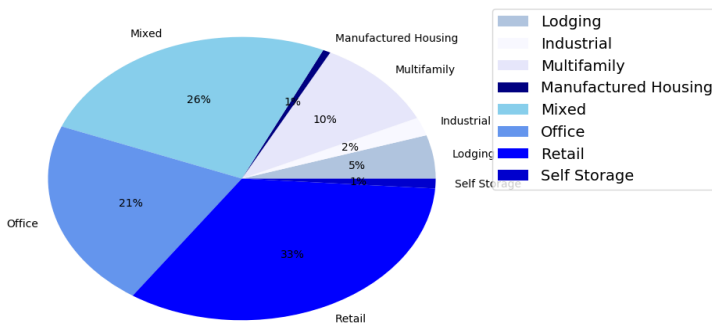

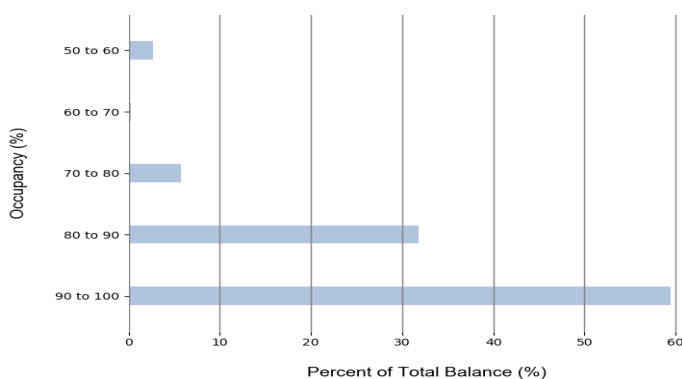

Occupancy Distribution (%)

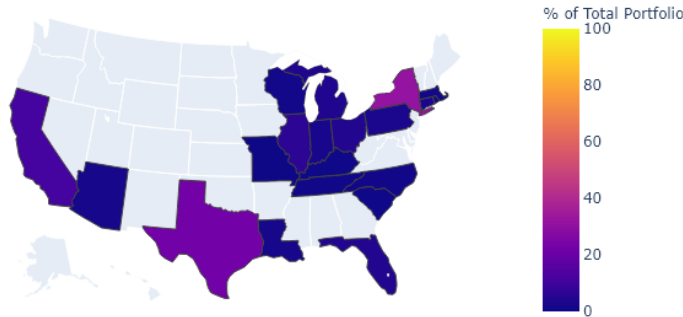

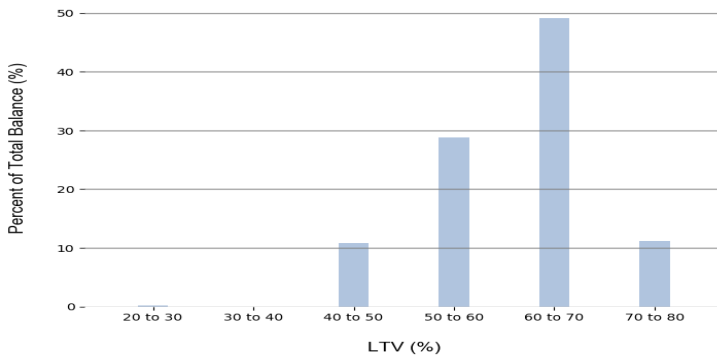
Local Distribution

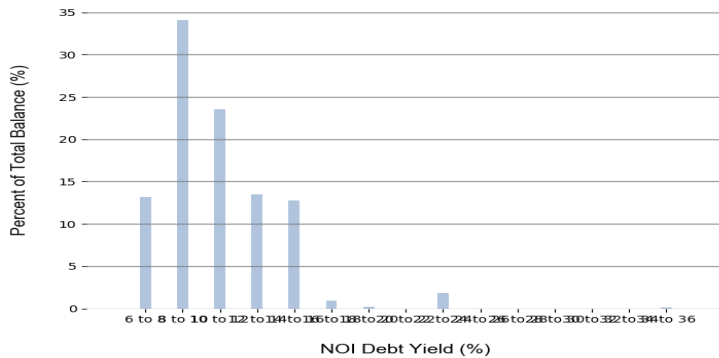

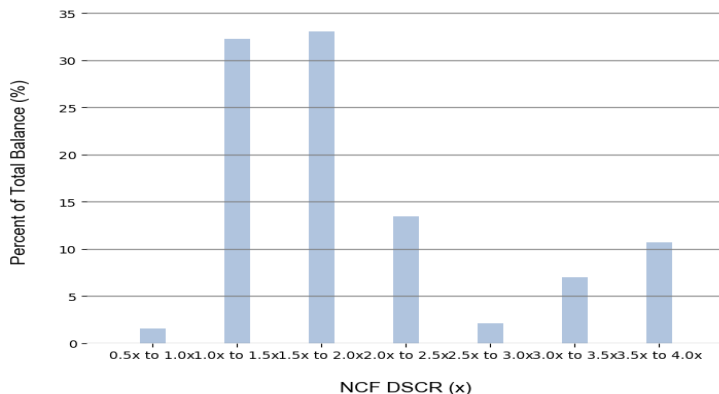
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

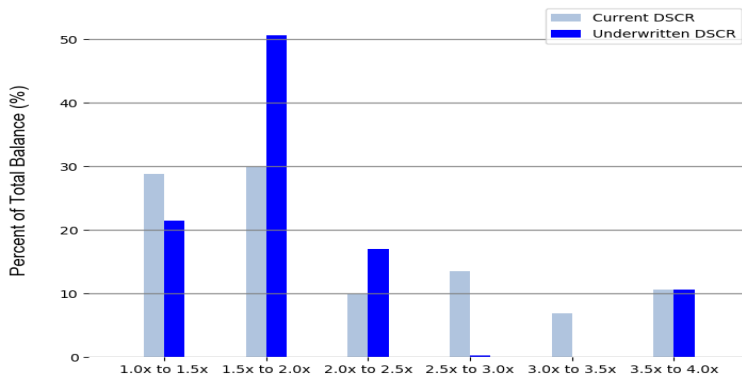


NCF DSCR ranged from 0.0x to 4.0x. There were 1 assets (1.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (32.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (33.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (13.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (2.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (6.9% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (10.7% of total balance) with NCF DSCR between 3.5x and 4.0x. 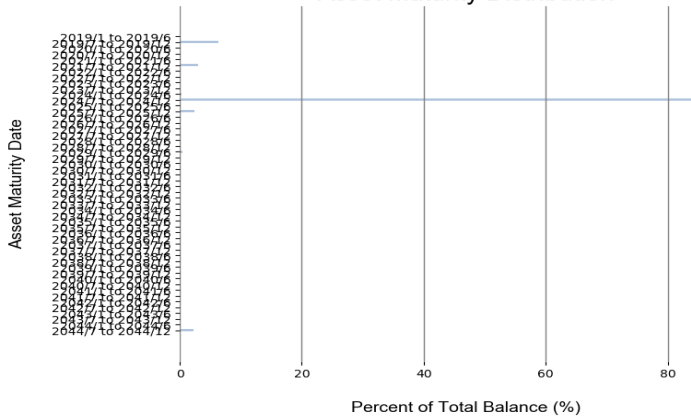
**DSCR Distribution (x)**



DSCRs ranged from 1.0x to 4.0x. There are 10 assets (28.8% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (30.0% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (10.1% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (13.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (6.9% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (10.7% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.1x.

There are 1 assets (6.3% of total balance) that have maturity dates between 2019/7 and 2019/12, 1 assets (3.0% of total balance) that have maturity dates between 2021/7 and 2021/12, 1 assets (0.3% of total balance) that have maturity dates between 2024/1 and 2024/6, 37 assets (85.2% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (2.3% of total balance) that have maturity dates between 2025/7 and 2025/12, 1 assets (0.5% of total balance) that have maturity dates between 2029/1 and 2029/6 and 2 assets (2.3% of total balance) that have maturity dates between 2044/7 and 2044/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
