Transaction Summary

The transaction closed on Oct 22 2014 and matures in Nov 2044. The pool's current aggregate principal balance is \$1021.4 million compared to \$1085.5 million at close.

The largest loan of the pool (11.3%) is secured by Grapevine Mills located in Fort Worth-Arlington, TX metropolitan area. Occupancy at the subject was 91%. The major tenants included Fieldhouse USA (7.94%) and Burlington Capital Group (7.48%). The second largest loan of the pool (11.3%) is secured by The Mall of Victor Valley located in metropolitan area. Occupancy at the subject was 99%. The major tenants included JC Penney (19.22%) and Sears (16.38%). The third largest loan of the pool (8.9%) is secured by Columbus Square Portfolio located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 94%. The major tenants included Whole Foods Market (24.27%) and Quick Park Garage LLC (21.94%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 91 months as of 04/15/2022, respectively. There are a total of 42 loans and 46 properties in the portfolio. The appraisal LTV was approximately 74.5% compared to the Original loan to value (LTV), which was approximately 62.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.79x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from -4% to 55% with a weighted average NOI debt yield of 9.4%. NOI debt yield ranged from -4% to 55%. There were 1 assets (3% of total balance) with NOI debt yield between -4% and -2%, 1 assets (3% of total balance) with NOI debt yield between 0% and 2%, 1 assets (7% of total balance) with NOI debt vield between 4% and 6%. 4 assets (21% of total balance) with NOI debt yield between 6% and 8%, 6 assets (10% of total balance) with NOI debt yield between 8% and 10%, 13 assets (37% of total balance) with NOI debt yield between 10% and 12%, 6 assets (3% of total balance) with NOI debt yield between 12% and 14%, 4 assets (14% of total balance) with NOI debt yield between 14% and 16%, 4 assets (2% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20% and 1 assets (0% of total balance) with NOI debt yield between 54% and 56%.

There were 1 assets (2.8% of total balance) with NCF DSCR between -0.5x and 0.0x, 1 assets (3.2% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (7.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 19 assets (38.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 10 assets (15.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (14.6% of total balance) with NCF DSCR between 2.0x and 2.5x and 2 assets (18.6% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 1.8x.







EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
