## Transaction Summary

The transaction closed on Nov 24 2014 and matures in Nov 2044. The pool's current aggregate principal balance is \$978.6 million compared to \$1039.1 million at close.

The largest loan of the pool (10.9%) is secured by CityPlace located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Arch Coal (9.19%) and Daugherty Systems (7.64%). The second largest loan of the pool (7.5%) is secured by Grapevine Mills located in Fort Worth-Arlington, TX metropolitan area. Occupancy at the subject was 94%. The major tenants included Fieldhouse USA (7.94%) and Burlington Capital Group (7.48%). The third largest loan of the pool (6.5%) is secured by Mall at Barnes Crossing and Market Center Tupelo located in metropolitan area. Occupancy at the subject was 83%. The major tenants included Belk's (14.19%) and JC Penney (13.69%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.47% and 74 months as of 12/15/2020, respectively. There are a total of 58 loans and 137 properties in the portfolio. The appraisal LTV was approximately 66.8% compared to the Original loan to value (LTV), which was approximately 66.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.98x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

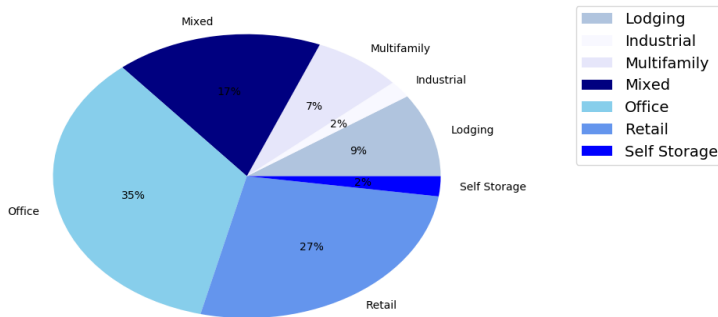

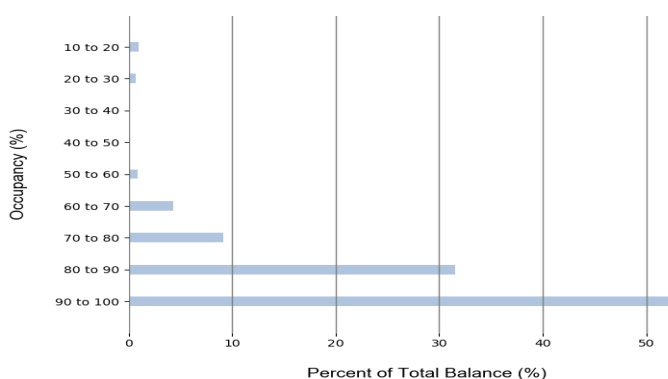

Occupancy Distribution (%)



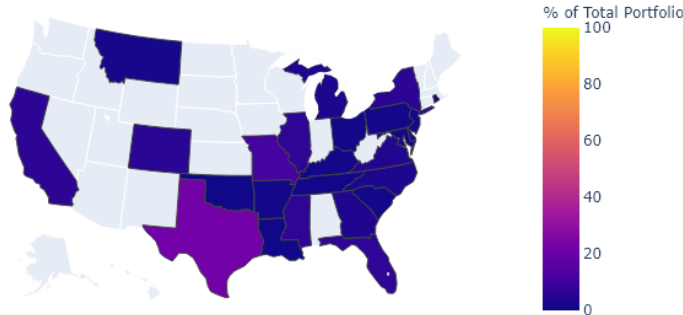

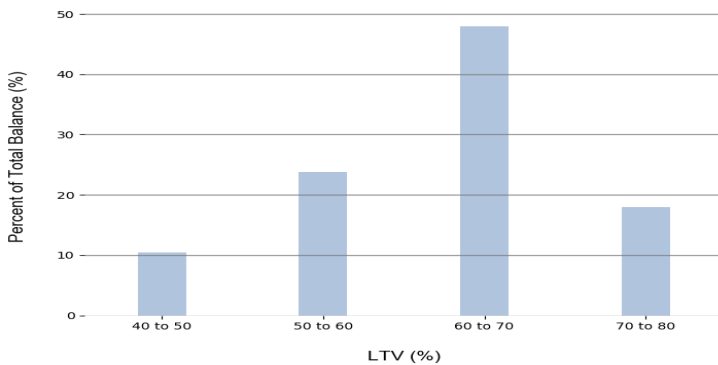
Local Distribution



Among assets in the portfolio, there are 8 properties (22% of total balance) located in Texas, 1 property (11% of total balance) in Missouri, 19 properties (7% of total balance) in Illinois, 1 property (6% of total balance) in Mississippi, 18 properties (6% of total balance) in Florida, 4 properties (6% of total balance) in California and 3 properties (6% of total balance) in New York. Other properties are located in the state of Virginia, Georgia, Michigan, North Carolina, Montana, Pennsylvania, Delaware, Rhode Island, Kentucky, South Carolina, Tennessee, New Jersey, Arkansas, Maryland, Ohio, Louisiana and Oklahoma.

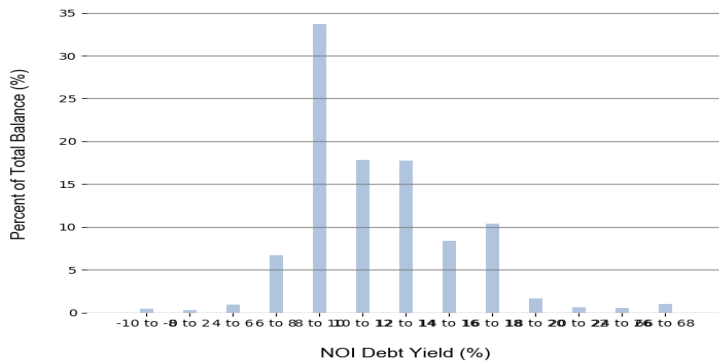

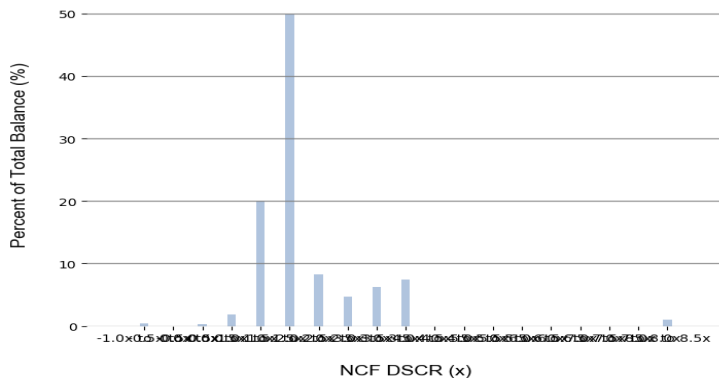
NOI Debt Yield (%)

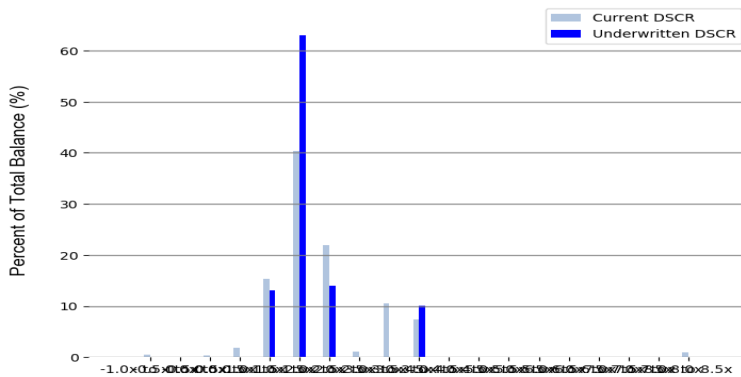

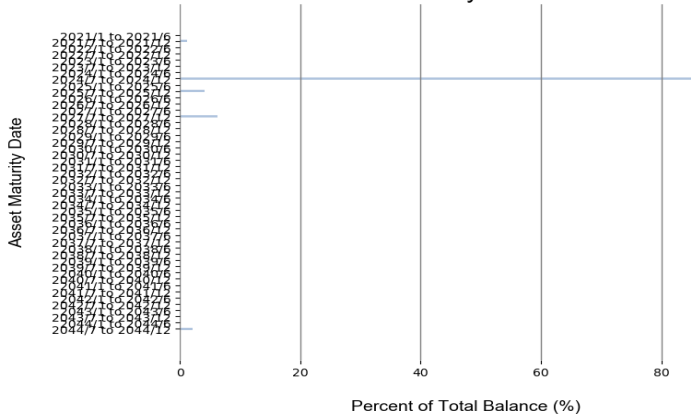
**DSCR Distribution (x)**

There are 1 assets (0.4% of total balance) with DSCR between -1.0x and -0.5x, 1 assets (0.3% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.8% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (15.3% of total balance) with DSCR between 1.0x and 1.5x, 26 assets (40.3% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (21.9% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (1.0% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (10.5% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (7.5% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.0% of total balance) with DSCR between 8.0x and 8.5x. There are 1 assets (1.3% of total balance) that have maturity dates between 2021/7 and 2021/12, 51 assets (86.3% of total balance) that have maturity dates between 2024/7 and 2024/12, 2 assets (4.1% of total balance) that have maturity dates between 2025/7 and 2025/12, 2 assets (6.2% of total balance) that have maturity dates between 2027/7 and 2027/12 and 2 assets (2.2% of total balance) that have maturity dates between 2044/7 and 2044/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
