Transaction Summary

The transaction closed on Nov 24 2014 and matures in Nov 2044. The pool's current aggregate principal balance is \$919.8 million compared to \$997.6 million at close.

The largest loan of the pool (11.4%) is secured by CityPlace located in metropolitan area. Occupancy at the subject was 93%. The major tenants included Arch Coal (9.19%) and Daugherty Systems (7.64%). The second largest loan of the pool (7.9%) is secured by Grapevine Mills located in Fort Worth-Arlington, TX metropolitan area. Occupancy at the subject was 98%. The major tenants included Fieldhouse USA (7.94%) and Burlington Capital Group (7.48%). The third largest loan of the pool (6.7%) is secured by Mall at Barnes Crossing and Market Center Tupelo located in metropolitan area. Occupancy at the subject was 82%. The major tenants included Belk's (14.19%) and JC Penney (13.69%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.46% and 89 months as of 03/15/2022, respectively. There are a total of 54 loans and 133 properties in the portfolio. The appraisal LTV was approximately 64.0% compared to the Original loan to value (LTV), which was approximately 65.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.81x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.



Type Concentration











EJR's Key Rating Features & Differences Compared With Other NRSROs

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
