Transaction Summary

The transaction closed on Nov 24 2014 and matures in Nov 2044. The pool's current aggregate principal balance is \$918.6 million compared to \$997.6 million at close.

The largest loan of the pool (11.4%) is secured by CityPlace located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Arch Coal (9.19%) and Daugherty Systems (7.64%). The second largest loan of the pool (7.9%) is secured by Grapevine Mills located in Fort Worth-Arlington, TX metropolitan area. Occupancy at the subject was 91%. The major tenants included Fieldhouse USA (7.94%) and Burlington Capital Group (7.48%). The third largest loan of the pool (6.7%) is secured by Mall at Barnes Crossing and Market Center Tupelo located in metropolitan area. Occupancy at the subject was 80%. The major tenants included Belk's (14.19%) and JC Penney (13.69%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.46% and 90 months as of 04/15/2022, respectively. There are a total of 54 loans and 133 properties in the portfolio. The appraisal LTV was approximately 63.8% compared to the Original loan to value (LTV), which was approximately 65.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.84x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





Occupancy Distribution (%)




Local Distribution



Among assets in the portfolio, there are 7 properties (21% of total balance) located in Texas, 1 property (11% of total balance) in Missouri, 19 properties (7% of total balance) in Illinois, 1 property (7% of total balance) in Mississippi, 18 properties (7% of total balance) in Florida, 4 properties (7% of total balance) in California and 3 properties (7% of total balance) in New York. 







There are 4 assets (7.6% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (2.7% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (17.1% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (40.6% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (11.1% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (1.0% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (11.0% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (7.9% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.0% of total balance) with DSCR between 10.5x and 11.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
