Transaction Summary

The transaction closed on Dec 29 2014 and matures in Oct 2039. The pool's current aggregate principal balance is \$1154.1 million compared to \$1227.2 million at close.

The largest loan of the pool (8.7%) is secured by 500 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included WW NORTON & COMPANY INC (14.33%) and ZARA USA INC (12.91%). The second largest loan of the pool (5.5%) is secured by 1515 Market located in Philadelphia, PA metropolitan area. Occupancy at the subject was 86%. The major tenants included Temple University of the Commonwealth (25.87%) and Heffler Radetich & Saitta LLP (4.23%). The third largest loan of the pool (4.2%) is secured by Heron Lakes located in metropolitan area. Occupancy at the subject was 83%. The major tenants included SURGE OPERATING LLC (12.55%) and INTERGRAPH CORPORATION (9.37%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 71 months as of 10/15/2020, respectively. There are a total of 59 loans and 71 properties in the portfolio. The appraisal LTV was approximately 63.8% compared to the Original loan to value (LTV), which was approximately 67.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.70x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





Occupancy Distribution (%)













EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
