Transaction Summary

The transaction closed on Dec 29 2014 and matures in Oct 2039. The pool's current aggregate principal balance is \$1140.3 million compared to \$1215.7 million at close.

The largest loan of the pool (8.8%) is secured by 500 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included W.W. NORTON & COMPANY INC. (14.33%) and ZARA USA INC. (9.41%). The second largest loan of the pool (5.5%) is secured by 1515 Market located in Philadelphia, PA metropolitan area. Occupancy at the subject was 85%. The major tenants included Temple University of the Commonwealth (25.87%) and Heffler Radetich & Saitta LLP (4.23%). The third largest loan of the pool (4.3%) is secured by Heron Lakes located in metropolitan area. Occupancy at the subject was 83%. The major tenants included SURGE OPERATING LLC (12.55%) and ICON BANK OF TEXAS (6.98%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 73 months as of 12/15/2020, respectively. There are a total of 58 loans and 65 properties in the portfolio. The appraisal LTV was approximately 63.3% compared to the Original loan to value (LTV), which was approximately 66.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.72x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.

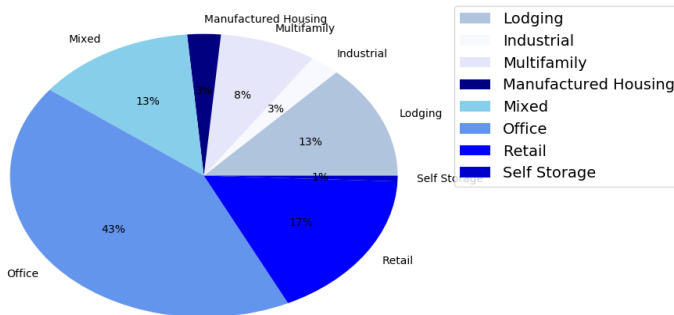

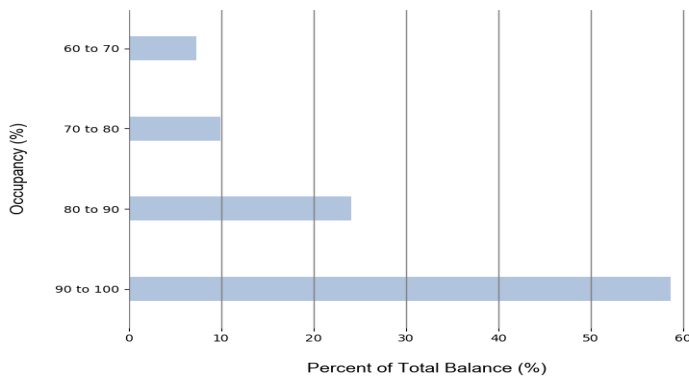

Occupancy Distribution (%)

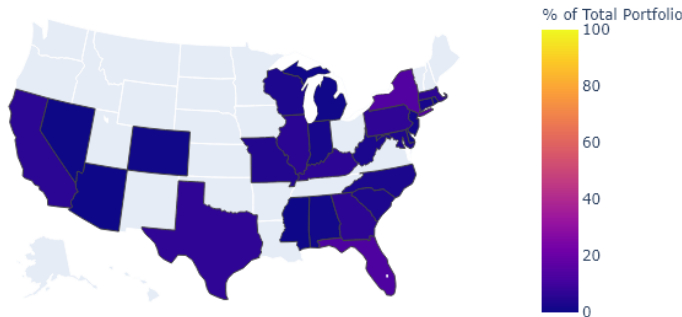

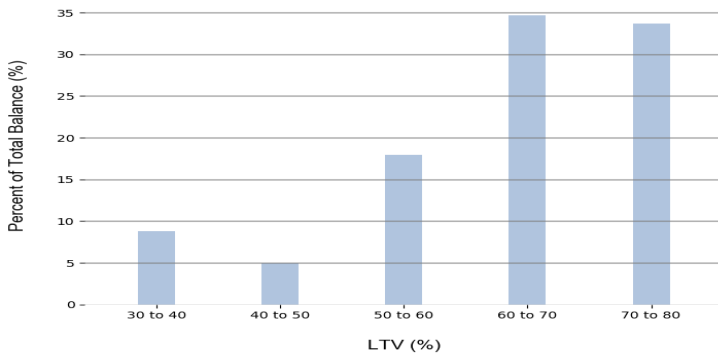
Local Distribution

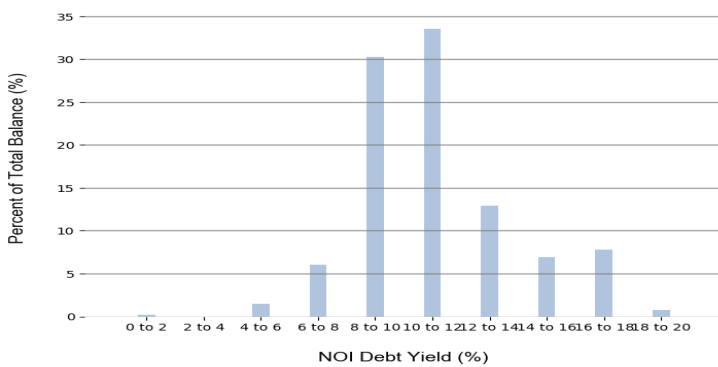

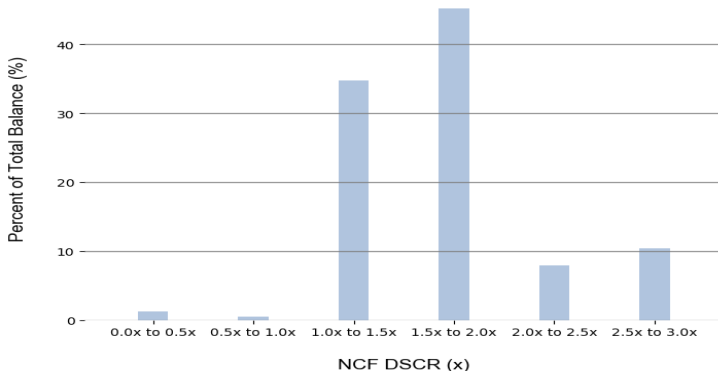
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

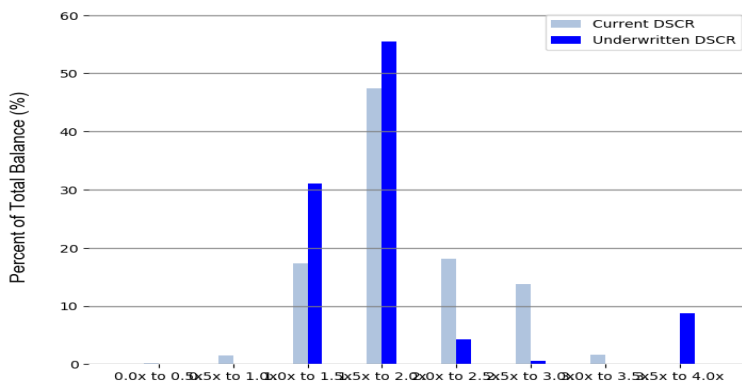

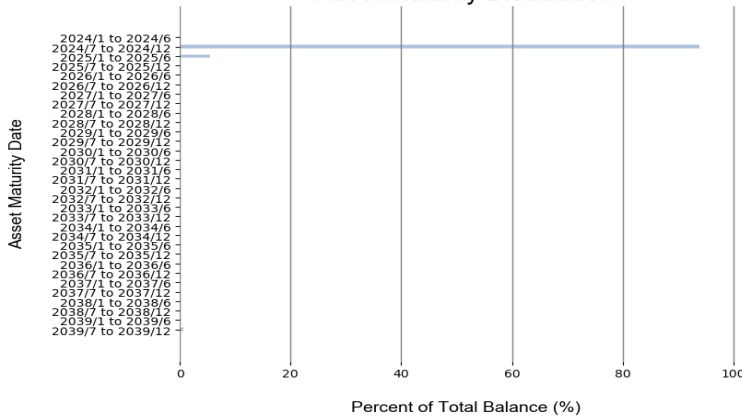
DSCR Distribution (x)

There are 1 assets (0.2% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.5% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (17.4% of total balance) with DSCR between 1.0x and 1.5x, 26 assets (47.4% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (18.2% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (13.7% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (1.6% of total balance) with DSCR between 3.0x and 3.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
