Transaction Summary

The transaction closed on Dec 29 2014 and matures in Oct 2039. The pool's current aggregate principal balance is \$1111.5 million compared to \$1213.6 million at close.

The largest loan of the pool (9.0%) is secured by 500 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 91%. The major tenants included W.W. NORTON & COMPANY INC. (14.33%) and ZARA USA INC. (9.41%). The second largest loan of the pool (5.5%) is secured by 1515 Market located in Philadelphia, PA metropolitan area. Occupancy at the subject was 83%. The major tenants included Temple University of the Commonwealth (25.93%) and Heffler Radetich & Saitta LLP (4.24%). The third largest loan of the pool (4.3%) is secured by Heron Lakes located in metropolitan area. Occupancy at the subject was 65%. The major tenants included SURGE OPERATING LLC (12.56%) and ICON BANK OF TEXAS (6.91%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 88 months as of 03/15/2022, respectively. There are a total of 57 loans and 63 properties in the portfolio. The appraisal LTV was approximately 65.8% compared to the Original loan to value (LTV), which was approximately 66.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.40x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 79%.

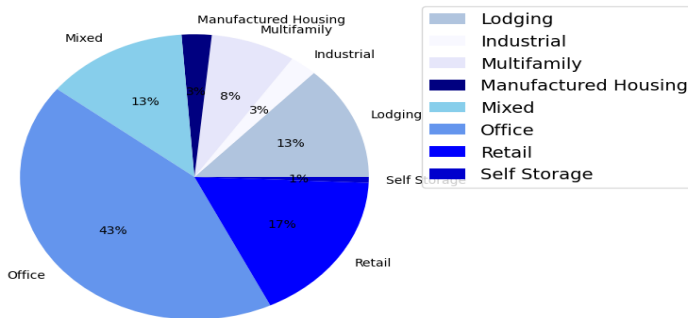

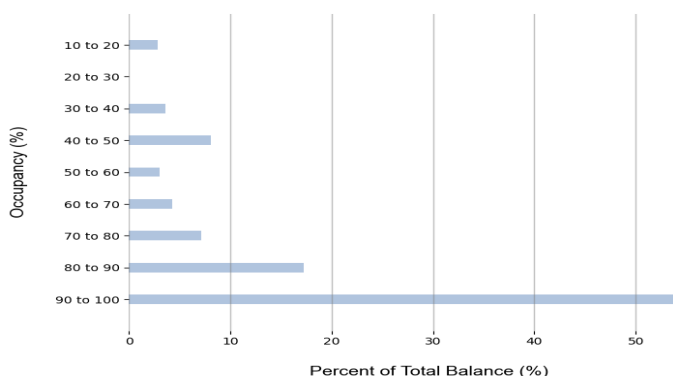

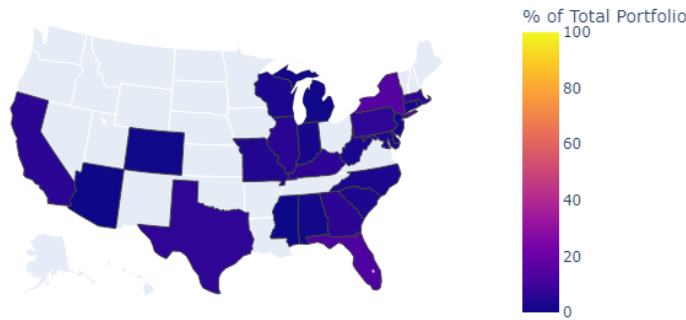

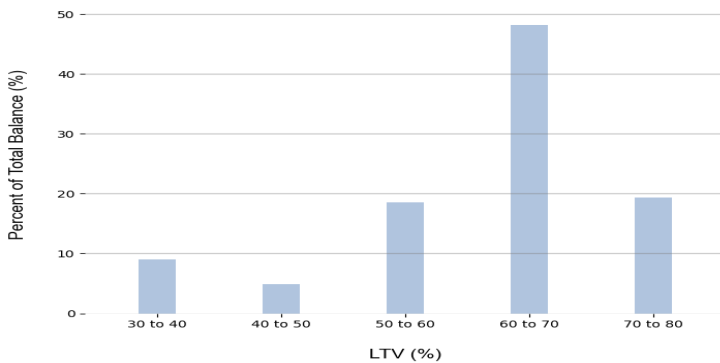
Local Distribution



Among assets in the portfolio, there are 4 properties (15% of total balance) located in New York, 11 properties (13% of total balance) in Florida, 4 properties (7% of total balance) in Texas, 3 properties (6% of total balance) in Pennsylvania, 3 properties (6% of total balance) in Massachusetts, 2 properties (6% of total balance) in Kentucky, 4 properties (6% of total balance) in Georgia and 6 properties (6% of total balance) in California. 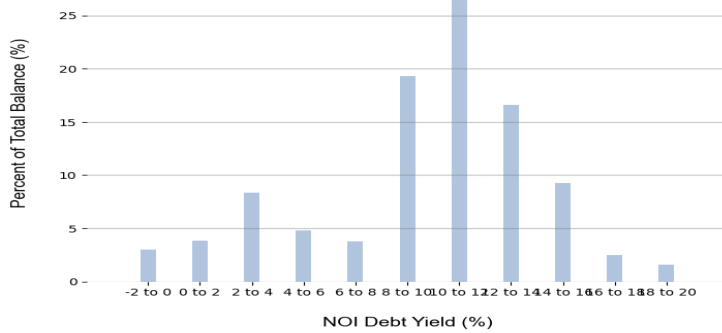

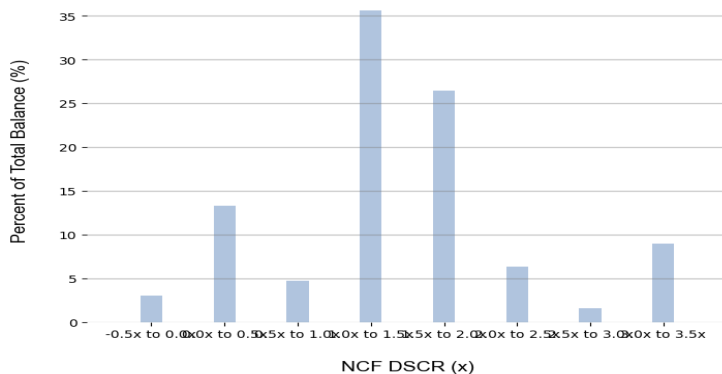
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

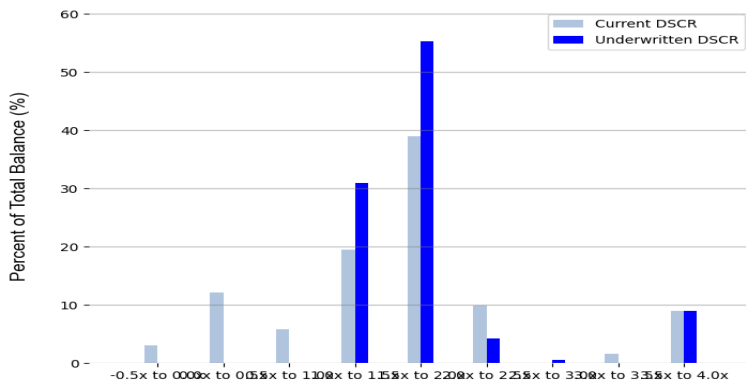

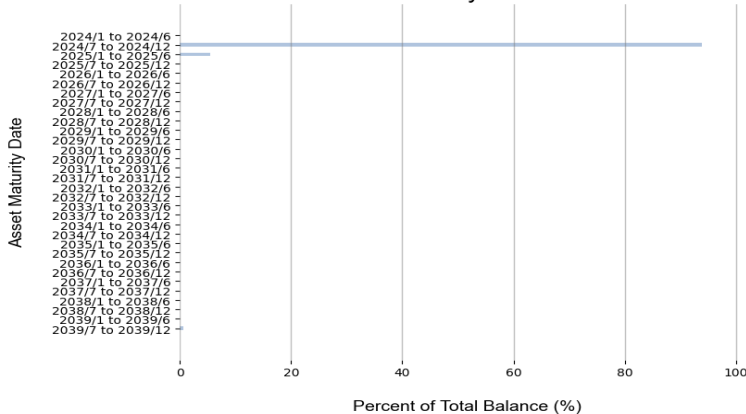
DSCR Distribution (x)

There are 1 assets (3.0% of total balance) with DSCR between -0.5x and 0.0x, 4 assets (12.2% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (5.9% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (19.5% of total balance) with DSCR between 1.0x and 1.5x, 26 assets (39.0% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (9.9% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (1.6% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (9.0% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.


