Transaction Summary

The transaction closed on Apr 23 2015 and matures in Oct 2035. The pool's current aggregate principal balance is \$920.6 million compared to \$961.4 million at close.

The largest loan of the pool (16.3%) is secured by Houston Galleria - Trust located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Galleria Tennis/Athletics (6.40%) and Forever 21 (2.23%). The second largest loan of the pool (8.4%) is secured by The Shops at Waldorf Center located in Washington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 81%. The major tenants included Christmas Tree Shops (7.08%) and Pharmhouse (6.21%). The third largest loan of the pool (4.8%) is secured by Aspen Heights Starkville located in metropolitan area. Occupancy at the subject was 93%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.17% and 68 months as of 10/15/2020, respectively. There are a total of 60 loans and 114 properties in the portfolio. The appraisal LTV was approximately 62.1% compared to the Original loan to value (LTV), which was approximately 62.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.34x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.








Local Distribution





Most recent net operating income debt yield ranged from -6% to 21% with a weighted average NOI debt yield of 11.1%. NOI debt yield ranged from -6% to 21%. There were 1 assets (0% of total balance) with NOI debt yield between -6% and -4%, 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 8 assets (27% of total balance) with NOI debt yield between 6% and 8%, 13 assets (14% of total balance) with NOI debt yield between 8% and 10%, 13 assets (13% of total balance) with NOI debt yield between 10% and 12%, 12 assets (28% of total balance) with NOI debt yield between 12% and 14%, 4 assets (3% of total balance) with NOI debt yield between 14% and 16%, 5 assets (10% of total balance) with NOI debt yield between 16% and 18%, 3 assets (2% of total balance) with NOI debt yield between 20% and 22%

NCF DSCR ranged from -1.0x to 5.0x. There were 1 assets (0.2% of total balance) with NCF DSCR between -0.5x and 0.0x, 2 assets (3.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 16 assets (17.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 27 assets (45.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (4.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (7.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.8% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (4.3% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (16.3% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from -0.5x to 5.0x.There are 1 assets (0.2% of total balance) with DSCR between -0.5x and 0.0x, 10 assets (9.3% of total balance) with DSCR between 1.0x and 1.5x, 28 assets (49.1% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (12.4% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (6.8% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.7% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (20.6% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.5x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
