Transaction Summary

The transaction closed on Apr 23 2015 and matures in Oct 2035. The pool's current aggregate principal balance is \$899.5 million compared to \$957.9 million at close.

The largest loan of the pool (16.7%) is secured by Houston Galleria - Trust located in metropolitan area. Occupancy at the subject was 83%. The major tenants included Galleria Tennis/Athletics (6.40%) and Forever 21 (2.23%). The second largest loan of the pool (8.4%) is secured by The Shops at Waldorf Center located in Washington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 81%. The major tenants included Christmas Tree Shops (7.08%) and Pharmhouse (6.21%). The third largest loan of the pool (4.8%) is secured by Aspen Heights Starkville located in metropolitan area. Occupancy at the subject was 79%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.16% and 85 months as of 03/15/2022, respectively. There are a total of 59 loans and 113 properties in the portfolio. The appraisal LTV was approximately 71.0% compared to the Original loan to value (LTV), which was approximately 62.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.03x. As of 03/15/2022, 0.16% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.





Occupancy Distribution (%)





Local Distribution











EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
