Transaction Summary

The transaction closed on Aug 28 2015 and matures in Apr 2029. The pool's current aggregate principal balance is \$876.2 million compared to \$963.2 million at close.

The largest loan of the pool (9.6%) is secured by Civic Opera Building located in metropolitan area. Occupancy at the subject was 75%. The major tenants included Bnd Civic Wacker LLC (6.90%) and TechNexus Facilities LLC (5.27%). The second largest loan of the pool (8.4%) is secured by The Roosevelt New Orleans Waldorf Astoria located in metropolitan area. Occupancy at the subject was 53%. The third largest loan of the pool (7.7%) is secured by Sunbelt Portfolio located in metropolitan area. Occupancy at the subject was 83%. The major tenants included NELSON MULLINS RILEY & SCARBOU (11.03%) and Burr & Forman LLP (7.89%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.64% and 79 months as of 03/15/2022, respectively. There are a total of 53 loans and 130 properties in the portfolio. The appraisal LTV was approximately 65.6% compared to the Original loan to value (LTV), which was approximately 68.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.40x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





Occupancy Distribution (%)




Local Distribution









EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
