Transaction Summary

The transaction closed on Oct 29 2015 and matures in Sep 2035. The pool's current aggregate principal balance is \$1074.8 million compared to \$1184.6 million at close.

The largest loan of the pool (6.6%) is secured by Hilton Suites Chicago Magnificent Mile located in metropolitan area. Occupancy at the subject was 79%. The second largest loan of the pool (6.7%) is secured by Civic Opera Building located in metropolitan area. Occupancy at the subject was 80%. The major tenants included Bnd Civic Wacker LLC (6.87%) and TechNexus Facilities LLC (5.25%). The third largest loan of the pool (5.6%) is secured by Palmer House Retail Shops located in metropolitan area. Occupancy at the subject was 98%. The major tenants included System Parking Inc. (49.06%) and Hilton Complex Sales (10.70%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.70% and 63 months as of 12/15/2020, respectively. There are a total of 78 loans and 260 properties in the portfolio. The appraisal LTV was approximately 63.7% compared to the Original loan to value (LTV), which was approximately 66.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.40x. As of 12/15/2020, 9.16% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

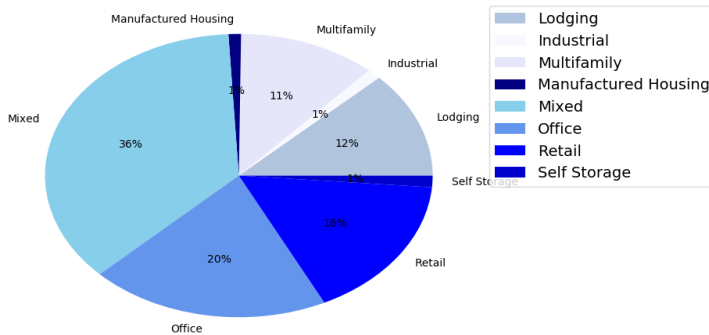

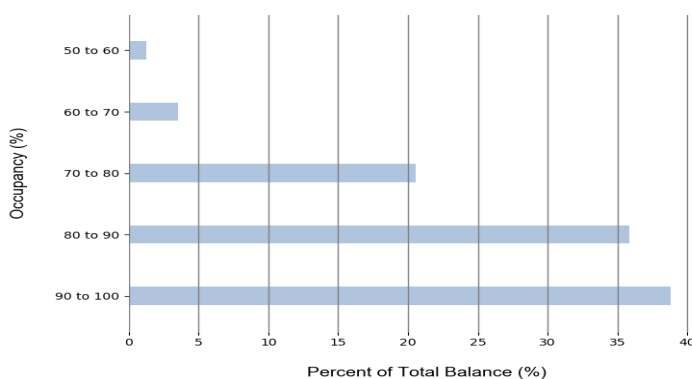

Occupancy Distribution (%)

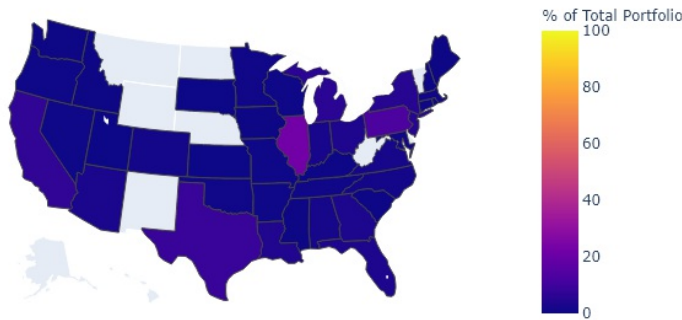

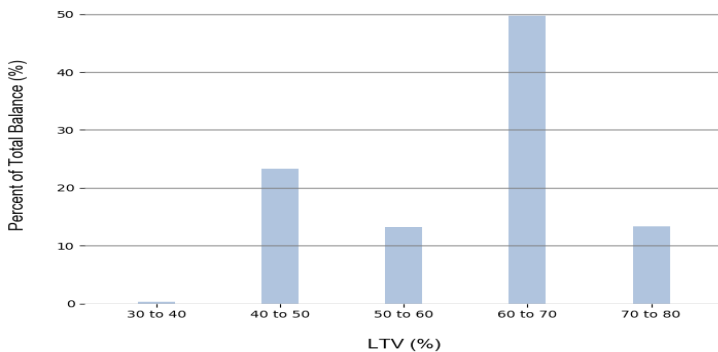
Local Distribution

LTV Distribution (%)



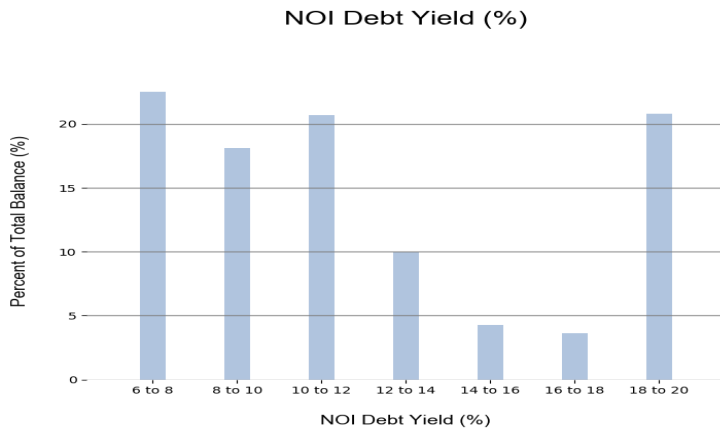

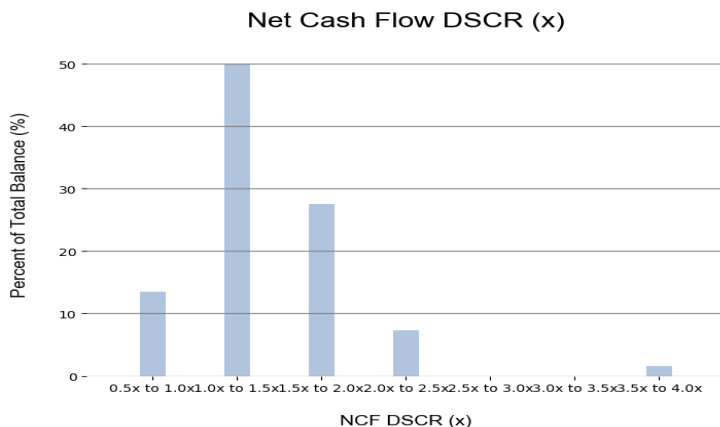

Most recent net operating income debt yield ranged from 6% to 19% with a weighted average NOI debt yield of 11.9%. NOI debt yield ranged from 6% to 19%. There were 5 assets (23% of total balance) with NOI debt yield between 6% and 8%, 14 assets (18% of total balance) with NOI debt yield between 8% and 10%, 23 assets (21% of total balance) with NOI debt yield between 10% and 12%, 20 assets (10% of total balance) with NOI debt yield between 12% and 14%, 11 assets (4% of total balance) with NOI debt yield between 14% and 16%, 4 assets (4% of total balance) with NOI debt yield between 16% and 18% and 1 assets (21% of total balance) with NOI debt yield between 18% and 20%.

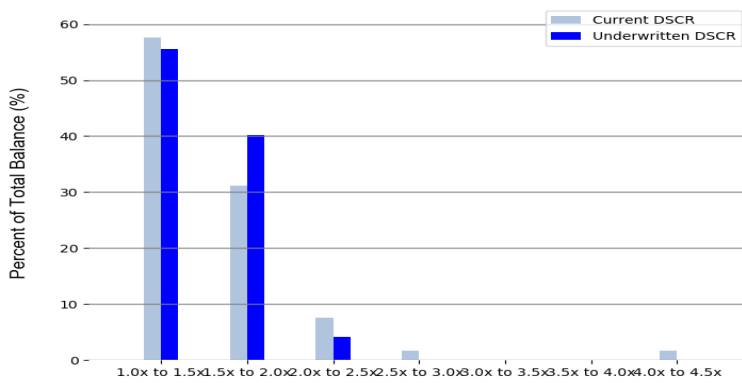


NCF DSCR ranged from 0.0x to 4.0x. There were 3 assets (13.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 25 assets (50.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 33 assets (27.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 16 assets (7.3% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (1.6% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 1.4x.

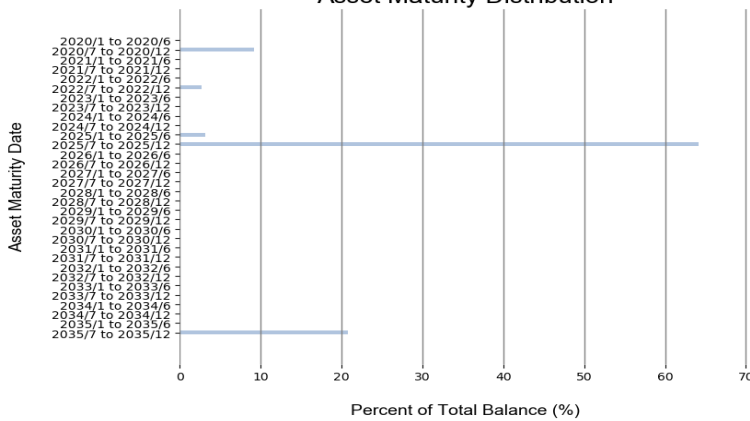
DSCR Distribution (x)



DSCRs ranged from 1.0x to 4.5x. There are 20 assets (57.6% of total balance) with DSCR between 1.0x and 1.5x, 35 assets (31.2% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (7.6% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (1.7% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (1.6% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 1.5x.

There are 2 assets (9.2% of total balance) that have maturity dates between 2020/7 and 2020/12, 1 assets (2.8% of total balance) that have maturity dates between 2022/7 and 2022/12, 4 assets (3.2% of total balance) that have maturity dates between 2025/1 and 2025/6, 70 assets (64.1% of total balance) that have maturity dates between 2025/7 and 2025/12 and 1 assets (20.8% of total balance) that have maturity dates between 2035/7 and 2035/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
