Transaction Summary

The transaction closed on Oct 29 2015 and matures in Sep 2035. The pool's current aggregate principal balance is \$1032.9 million compared to \$1176.1 million at close.

The largest loan of the pool (6.7%) is secured by Hilton Suites Chicago Magnificent Mile located in metropolitan area. Occupancy at the subject was 79%. The second largest loan of the pool (6.8%) is secured by Civic Opera Building located in metropolitan area. Occupancy at the subject was 80%. The major tenants included Bnd Civic Wacker LLC (6.87%) and TechNexus Facilities LLC (5.25%). The third largest loan of the pool (5.7%) is secured by Palmer House Retail Shops located in metropolitan area. Occupancy at the subject was 98%. The major tenants included System Parking Inc. (49.06%) and Hilton Complex Sales (10.70%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.71% and 78 months as of 03/15/2022, respectively. There are a total of 77 loans and 259 properties in the portfolio. The appraisal LTV was approximately 80.9% compared to the Original loan to value (LTV), which was approximately 66.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.39x. As of 03/15/2022, 12.09% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

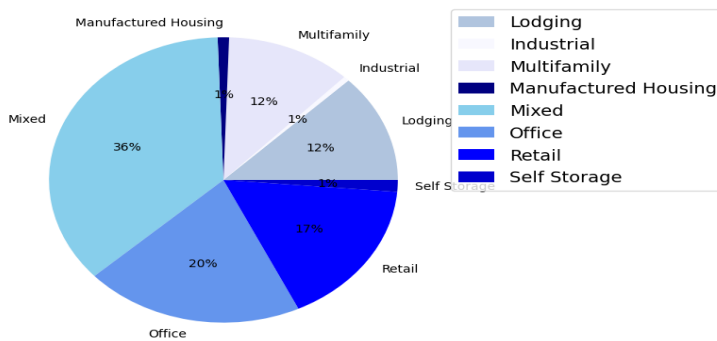

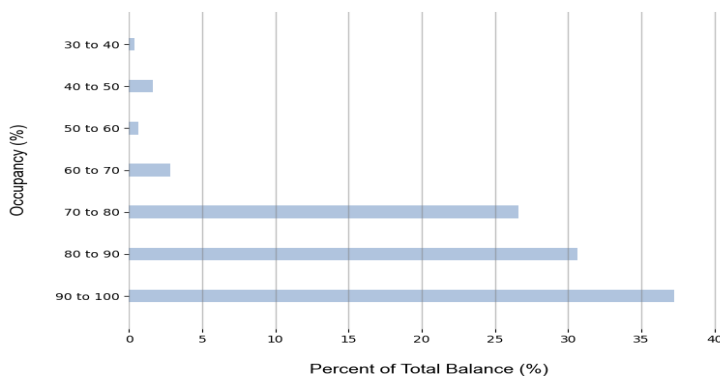

Occupancy Distribution (%)

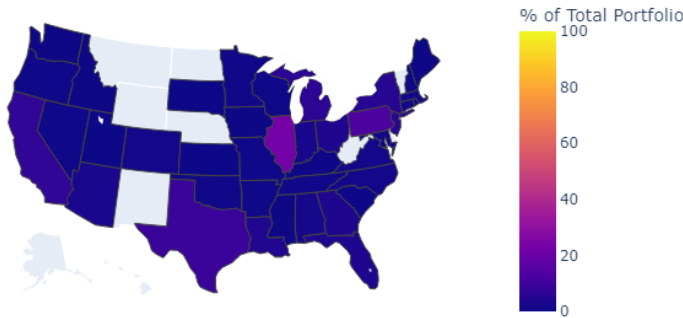

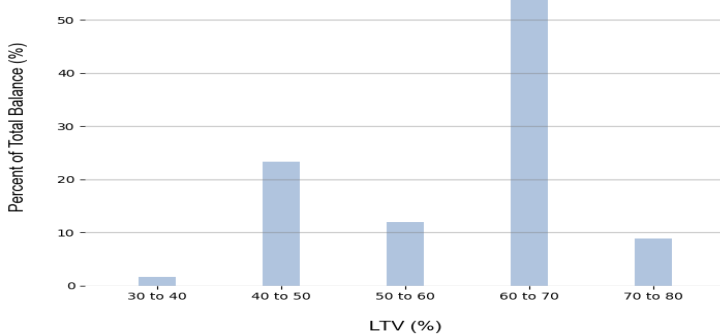
Local Distribution

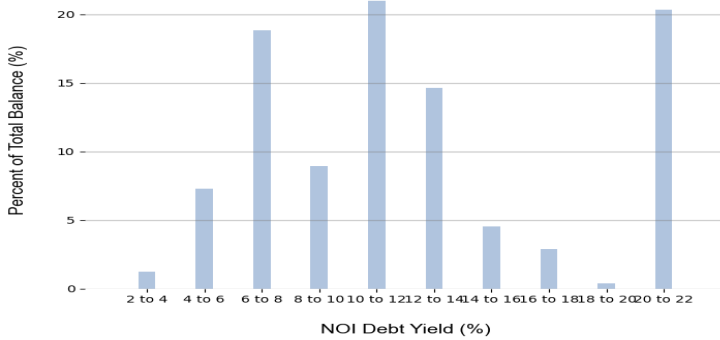

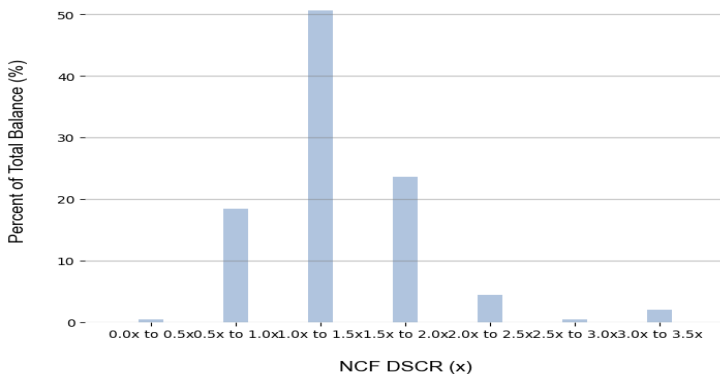
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

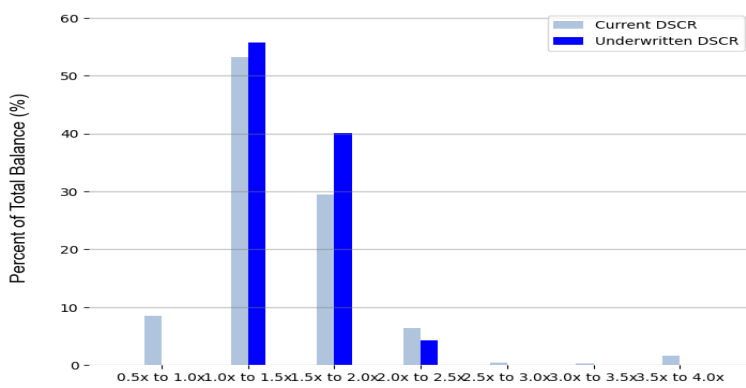

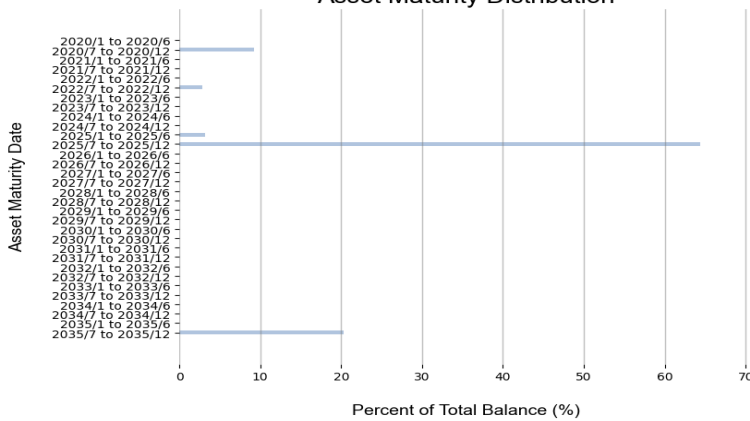
DSCR Distribution (x)



DSCRs ranged from 0.5x to 4.0x. There are 3 assets (8.5% of total balance) with DSCR between 0.5x and 1.0x, 22 assets (53.3% of total balance) with DSCR between 1.0x and 1.5x, 35 assets (29.4% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (6.4% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (0.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.3% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (1.6% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
