Transaction Summary

The transaction closed on Oct 29 2015 and matures in Sep 2035. The pool's current aggregate principal balance is \$1013.8 million compared to \$1156.1 million at close.

The largest loan of the pool (6.8%) is secured by Hilton Suites Chicago Magnificent Mile located in metropolitan area. Occupancy at the subject was 79%. The second largest loan of the pool (7.0%) is secured by Civic Opera Building located in metropolitan area. Occupancy at the subject was 80%. The major tenants included Bnd Civic Wacker LLC (6.87%) and TechNexus Facilities LLC (5.25%). The third largest loan of the pool (5.8%) is secured by Palmer House Retail Shops located in metropolitan area. Occupancy at the subject was 66%. The major tenants included System Parking Inc. (49.06%) and Hilton Complex Sales (10.70%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.70% and 79 months as of 04/15/2022, respectively. There are a total of 76 loans and 201 properties in the portfolio. The appraisal LTV was approximately 81.4% compared to the Original loan to value (LTV), which was approximately 67.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.30x. As of 04/15/2022, 12.30% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.





Occupancy Distribution (%)









There were 6 assets (10.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (17.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 28 assets (43.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 25 assets (21.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (4.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (0.5% of total balance) with NCF DSCR between 2.5x and 3.0x and 2 assets (2.0% of total balance) with NCF DSCR between 3.0x and 3.5x. 



There are 3 assets (6.6% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (14.8% of total balance) with DSCR between 0.5x and 1.0x, 19 assets (45.0% of total balance) with DSCR between 1.0x and 1.5x, 33 assets (26.3% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (4.9% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (0.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.3% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (1.7% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
