# **Transaction Summary**

The transaction closed on Mar 15 2016 and matures in Feb 2036. The pool's current aggregate principal balance is \$971.5 million compared to \$1001.7 million at close.

The largest loan of the pool (9.8%) is secured by 215 Park Avenue South located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 91%. The major tenants included Industrious NYC 215 (20.42%) and Rakuten Marketing LL (10.64%). The second largest loan of the pool (8.0%) is secured by 5 Penn Plaza located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 94%. The major tenants included Sirius XM (14.88%) and Thomas Publishing Company (14.28%). The third largest loan of the pool (7.5%) is secured by 32 Avenue of the Americas located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included AMFM OPERATING INC (14.56%) and DENTSU HOLDINGS USA INC. (14.52%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.75% and 59 months as of 12/15/2020, respectively. There are a total of 47 loans and 107 properties in the portfolio. The appraisal LTV was approximately 60.3% compared to the Original loan to value (LTV), which was approximately 61.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.86x. As of 12/15/2020, 9.10% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.





#### Occupancy Distribution (%)




#### Local Distribution





There were 1 assets (1.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (4.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 16 assets (15.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 16 assets (44.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (16.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (17.1% of total balance) with NCF DSCR between 4.0x and 4.5x. 



# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
