## Transaction Summary

The transaction closed on Nov 21 2013 and matures in Nov 2033. The pool's current aggregate principal balance is \$802.9 million compared to \$881.4 million at close.

The largest loan of the pool (15.4%) is secured by The Aire located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 86%. The major tenants included Mandell School (0.00%) and Flywheel Sports, Inc. (0.00%). The second largest loan of the pool (7.5%) is secured by Energy Centre located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Chaffe McCall LLP (4.99%) and Fritel LLC (4.38%). The third largest loan of the pool (6.1%) is secured by Oracle & International Centre located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Oracle Corporation (25.31%) and The Ogilvy Group Inc. (9.66%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.04% and 86 months as of 12/15/2020, respectively. There are a total of 50 loans and 53 properties in the portfolio. The appraisal LTV was approximately 63.1% compared to the Original loan to value (LTV), which was approximately 66.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.35x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.

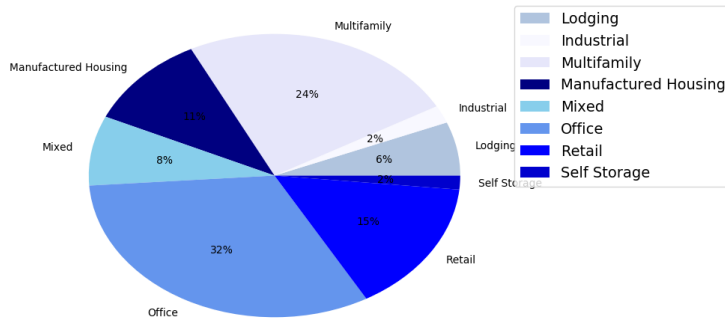

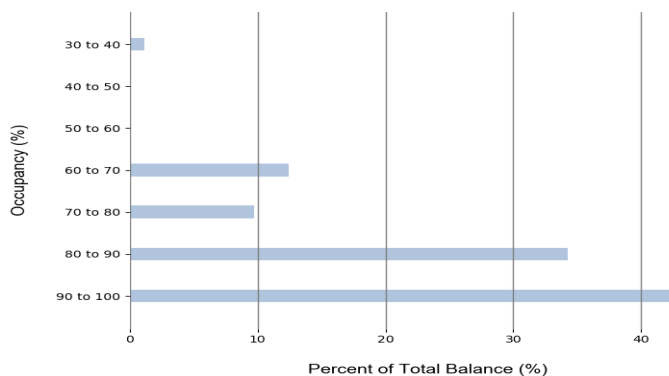

Occupancy Distribution (%)

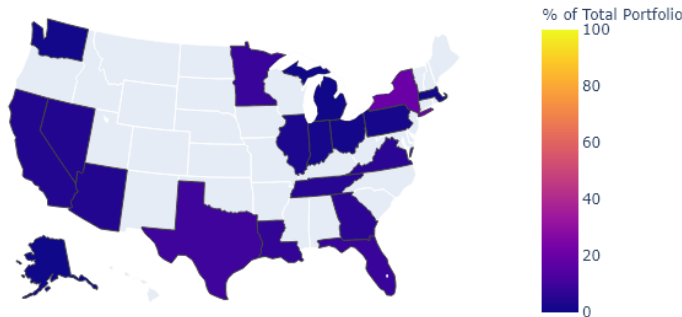

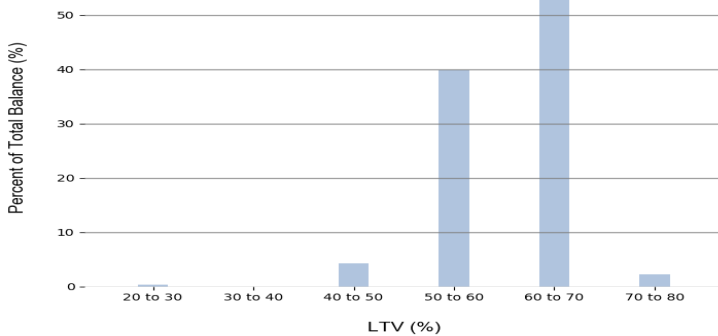
Local Distribution

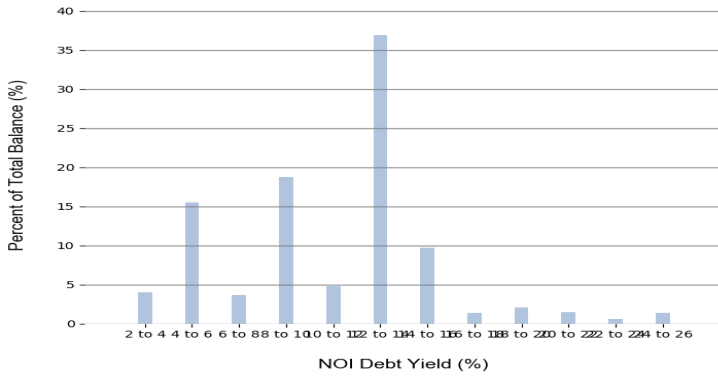

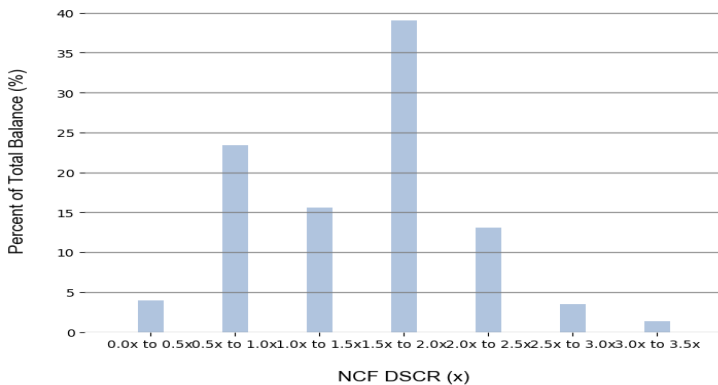
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 2% to 25% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 2% to 25%. Net Cash Flow DSCR (x)

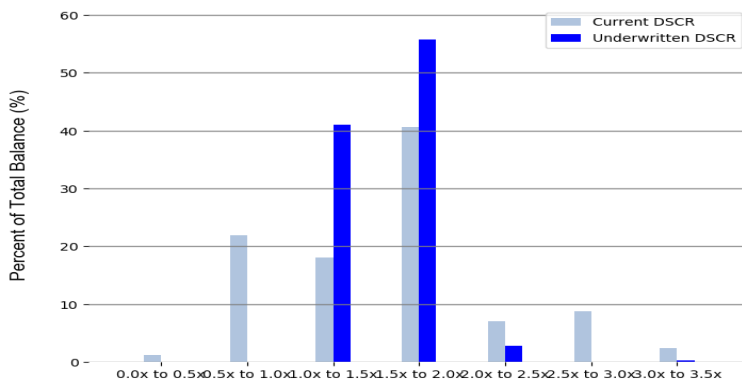

There were 3 assets (4.0% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (23.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 11 assets (15.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 20 assets (39.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (13.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (3.5% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (1.4% of total balance) with NCF DSCR between 3.0x and 3.5x. 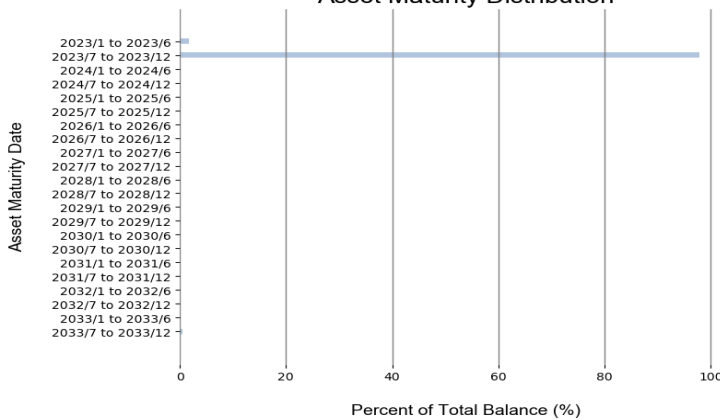
**DSCR Distribution (x)**

There are 1 assets (1.2% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (21.9% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (18.0% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (40.6% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (7.1% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (8.7% of total balance) with DSCR between 2.5x and 3.0x and 2 assets (2.5% of total balance) with DSCR between 3.0x and 3.5x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
