### **Transaction Summary**

The transaction closed on Nov 21 2013 and matures in Nov 2033. The pool's current aggregate principal balance is \$719.5 million compared to \$810.7 million at close.

The largest loan of the pool (16.8%) is secured by The Aire located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Mandell School (0.00%) and Flywheel Sports, Inc. (0.00%). The second largest loan of the pool (8.1%) is secured by Energy Centre located in metropolitan area. Occupancy at the subject was 91%. The major tenants included Louisiana Children's Medical Center (5.42%) and Chaffe McCall LLP (4.96%). The third largest loan of the pool (6.7%) is secured by Oracle & International Centre located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Oracle Corporation (25.31%) and The Ogilvy Group Inc. (9.66%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.02% and 102 months as of 04/15/2022, respectively. There are a total of 46 loans and 49 properties in the portfolio. The appraisal LTV was approximately 61.8% compared to the Original loan to value (LTV), which was approximately 65.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.16x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.



Type Concentration







DSCRs ranged from 0.0x to 4.0x. There are 2 assets (17.3% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (12.6% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (21.5% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (27.0% of total balance) with DSCR between 1.5x and 2.0x, 2 assets (8.6% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (10.9% of total balance) with DSCR between 2.0x and 3.5x and 3.0x, 1 assets (1.5% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.6% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.2x.

There are 3 assets (27.4% of total balance) that have maturity dates between 2023/1 and 2023/6, 42 assets (688.3% of total balance) that have maturity dates between 2023/7 and 2023/12 and 1 assets (3.9% of total balance) that have maturity dates between 2033/7 and 2033/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
