Transaction Summary

The transaction closed on Jul 29 2016 and matures in Feb 2027. The pool's current aggregate principal balance is \$888.5 million compared to \$919.4 million at close.

The largest loan of the pool (9.0%) is secured by Opry Mills located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Bass Pro Shops (11.13%) and Regal Cinemas (8.55%). The second largest loan of the pool (9.0%) is secured by Center 21 located in Oakland-Hayward-Berkeley, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Pandora Media INC (15.69%) and Kaiser Foundation Health Plan (13.93%). The third largest loan of the pool (6.9%) is secured by 693 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 66%. The major tenants included VALENTINO U.S.A. INC (15.05%) and Jellyfish Group Ltd (9.85%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.55% and 55 months as of 12/15/2020, respectively. There are a total of 45 loans and 75 properties in the portfolio. The appraisal LTV was approximately 58.3% compared to the Original loan to value (LTV), which was approximately 60.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.97x. As of 12/15/2020, 0.60% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 11.6%. NOI debt yield ranged from 4% to 25%. There were 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 4 assets (12% of total balance) with NOI debt yield between 6% and 8%, 11 assets (18% of total balance) with NOI debt yield between 8% and 10%, 10 assets (31% of total balance) with NOI debt yield between 10% and 12%, 6 assets (15% of total balance) with NOI debt yield between 12% and 14%, 9 assets (17% of total balance) with NOI debt yield between 14% and 16%, 2 assets (4% of total balance) with NOI debt yield between 16% and 18%, 1 assets (2% of total balance) with NOI debt yield between 20% and 22%, 1 assets (0% of total balance) with NOI debt yield between 24% and 26%

NCF DSCR ranged from 0.0x to 4.0x. There were 4 assets (6.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 11 assets (21.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (27.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (20.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (15.8% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (3.9% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (5.6% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 2.0x.







DSCRs ranged from 1.0x to 4.0x.There are 12 assets (23.1% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (21.7% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (21.8% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (17.3% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (8.6% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (6.6% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.1x.

There are 1 assets (0.6% of total balance) that have maturity dates between 2021/1 and 2021/6, 4 assets (3.8% of total balance) that have maturity dates between 2025/7 and 2025/12, 29 assets (56.9% of total balance) that have maturity dates between 2026/1 and 2026/6, 10 assets (37.8% of total balance) that have maturity dates between 2026/7 and 2026/12 and 1 assets (0.8% of total balance) that have maturity dates between 2027/1 and 2027/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
