## Transaction Summary

The transaction closed on Dec 22 2016 and matures in Apr 2027. The pool's current aggregate principal balance is \$847.0 million compared to \$882.8 million at close.

The largest loan of the pool (11.1%) is secured by Hilton Hawaiian Village - Trust located in metropolitan area. Occupancy at the subject was 55%. The second largest loan of the pool (9.4%) is secured by Fresno Fashion Fair Mall located in metropolitan area. Occupancy at the subject was 85%. The major tenants included JC Penney (28.68%) and X Lanes (5.29%). The third largest loan of the pool (7.4%) is secured by 9 West 57th Street - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 71%. The major tenants included Kohlberg, Kravis, Roberts & Co. (11.67%) and Chanel Inc. (11.02%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.15% and 65 months as of 03/15/2022, respectively. There are a total of 36 loans and 68 properties in the portfolio. The appraisal LTV was approximately 56.4% compared to the Original loan to value (LTV), which was approximately 56.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.94x. As of 03/15/2022, 1.97% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 81%.

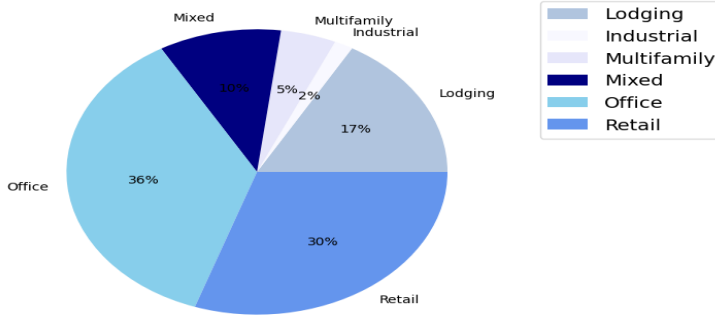

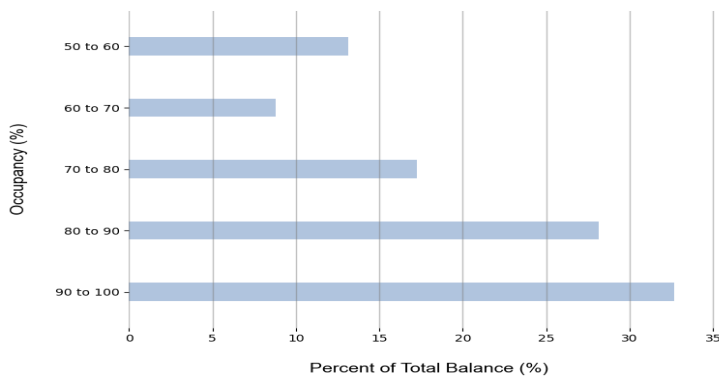

### Occupancy Distribution (%)

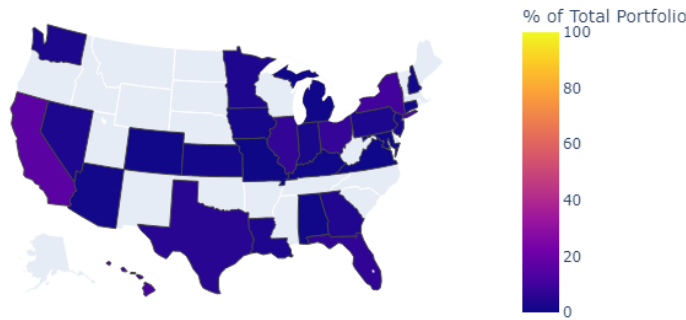

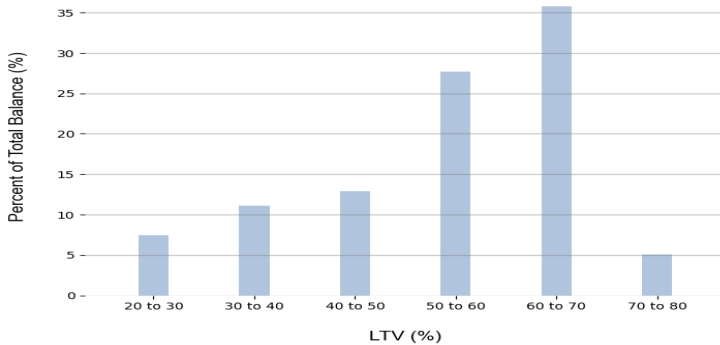
Local Distribution

Other properties are located in the state of Louisiana, Minnesota, Nevada, Pennsylvania, Washington, Indiana, New Jersey, Iowa, Kansas, Arizona, New Hampshire, Maryland, Michigan, Colorado, Kentucky, Connecticut, Alabama, Virginia and Missouri.

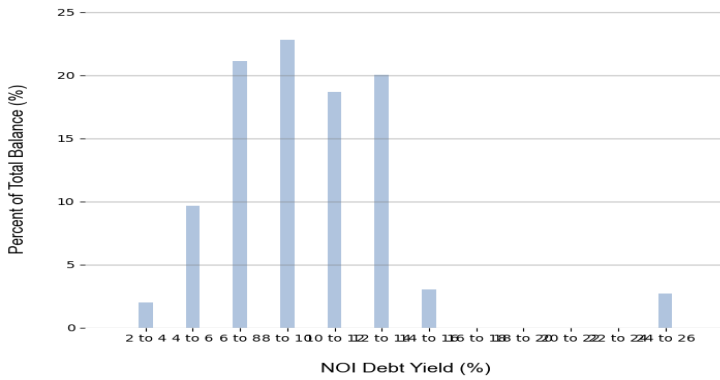

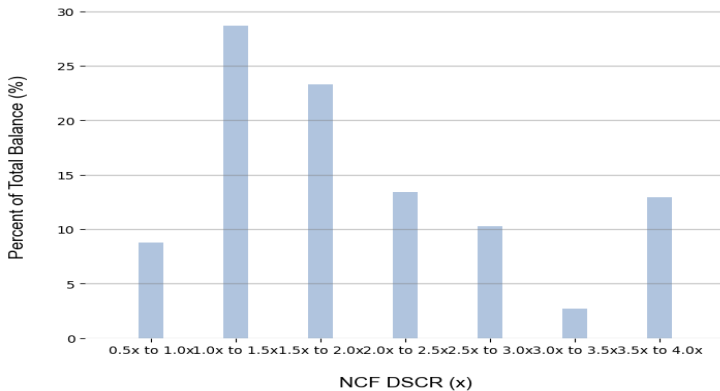
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 2% to 25% with a weighted average NOI debt yield of 9.9%. NOI debt yield ranged from 2% to 25%. There were 1 assets (2% of total balance) with NOI debt yield between 2% and 4%, 2 assets (10% of total balance) with NOI debt yield between 4% and 6%, 4 assets (21% of total balance) with NOI debt yield between 6% and 8%, 14 assets (23% of total balance) with NOI debt yield between 8% and 10%, 6 assets (19% of total balance) with NOI debt yield between 10% and 12%, 6 assets (20% of total balance) with NOI debt yield between 12% and 14%, 2 assets (3% of total balance) with NOI debt yield between 14% and 16%, 1 assets (3% of total balance) with NOI debt yield between 24% and 26%

Net Cash Flow DSCR (x)

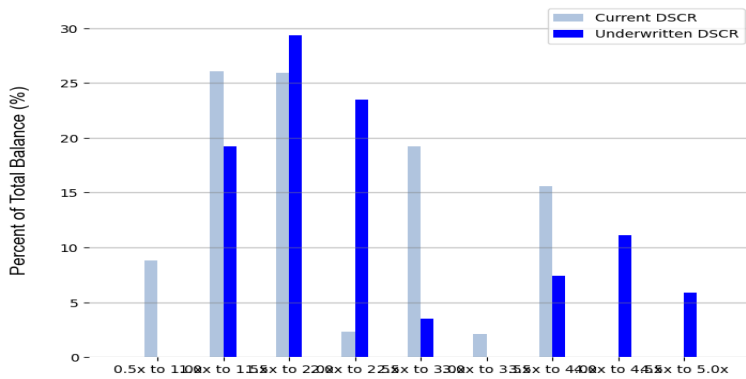


NCF DSCR ranged from 0.5x to 4.0x. There were 2 assets (8.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (28.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 11 assets (23.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 2 assets (13.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (10.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (2.7% of total balance) with NCF DSCR between 3.0x and 3.5x and 2 assets (12.9% of total balance) with NCF DSCR between 3.5x and 4.0x. 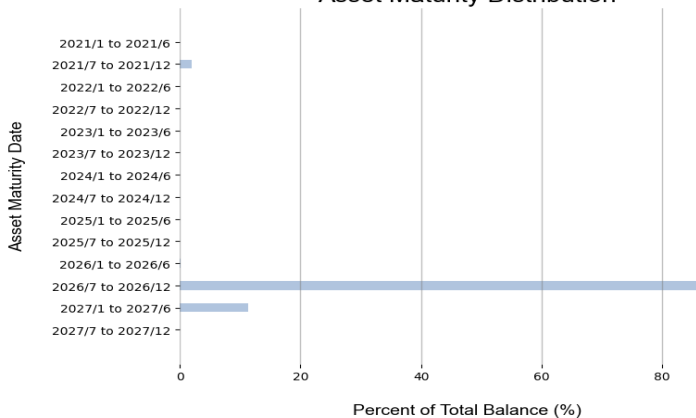
**DSCR Distribution (x)**



DSCRs ranged from 0.5x to 4.0x. There are 2 assets (8.8% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (26.1% of total balance) with DSCR between 1.0x and 1.5x, 13 assets (25.9% of total balance) with DSCR between 1.5x and 2.0x, 1 assets (2.3% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (19.2% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (2.1% of total balance) with DSCR between 3.0x and 3.5x and 3 assets (15.6% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.1x.

There are 1 assets (16.7% of total balance) that have maturity dates between 2021/7 and 2021/12, 1 assets (1.1% of total balance) that have maturity dates between 2026/1 and 2026/6, 31 assets (73.2% of total balance) that have maturity dates between 2026/7 and 2026/12 and 3 assets (96.0% of total balance) that have maturity dates between 2027/1 and 2027/6.

## Sensitivity Analysis

### Summary

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

### 2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

### 3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

### 4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
- 3). Do not address whether the expected return of a particular investment is adequate for the inherent risk.
- 4). Do not address whether the market value of the security will remain stable over time.
- 5). Are not exact measures of the probability of default but are instead expressions of the relative credit risk of issuers and debt instruments.

In some cases, the information is limited because of issues such as the lack of reported data. Such shortcomings are not always readily apparent. EJR aims to identify such shortcomings and make adjustments using its best judgement.

EJR's rating aims to assess the possible loss of investing in the obligations. Factors which affect such projection, and in turn EJRs rating, include changes in the credit worthiness of the collateral assets, changes in the correlation between them, and overall economic changes.


