Transaction Summary

The transaction closed on Nov 06 2017 and matures in Oct 2021. The pool's current aggregate principal balance is \$346.7 million compared to \$349.8 million at close.

The largest loan of the pool (27.1%) is secured by The Centre at Purchase located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included Endurance Reinsurance (10.90%) and National Public Financial (6.19%). The second largest loan of the pool (21.1%) is secured by Bank of America Campus located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Bank Of America (100.00%). The third largest loan of the pool (18.8%) is secured by Hyatt Regency Jacksonville Riverfront located in metropolitan area. Occupancy at the subject was 70%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.07% and 38 months as of 10/15/2020, respectively. There are a total of 5 loans and 5 properties in the portfolio. The appraisal LTV was approximately 51.4% compared to the Original loan to value (LTV), which was approximately 52.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.65x. As of 10/15/2020, 14.97% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 80%.

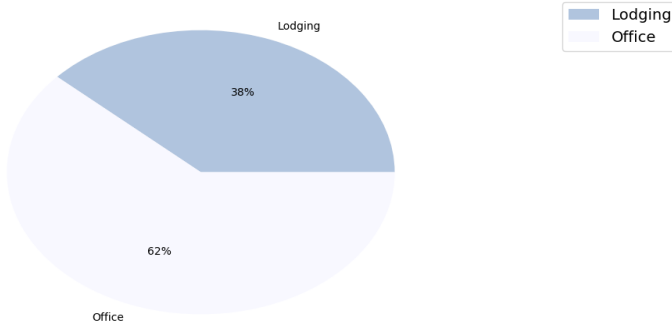

Among assets in the portfolio, Lodging properties accounted for 38% of total balance and Office properties accounted for 62% of total balance.

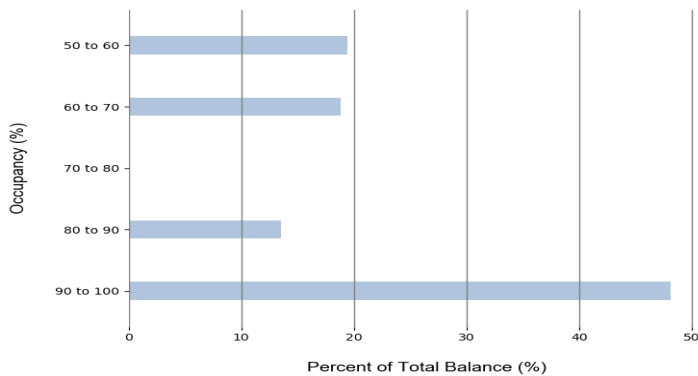

Occupancy Distribution (%)

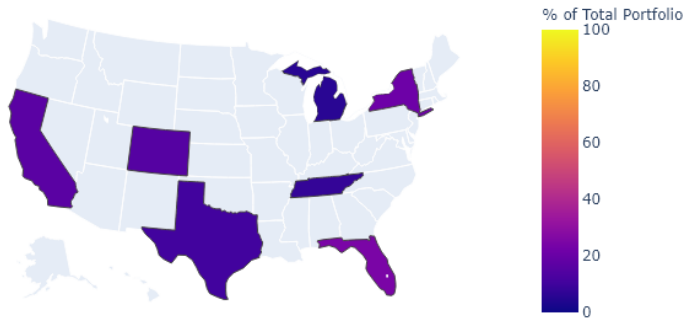

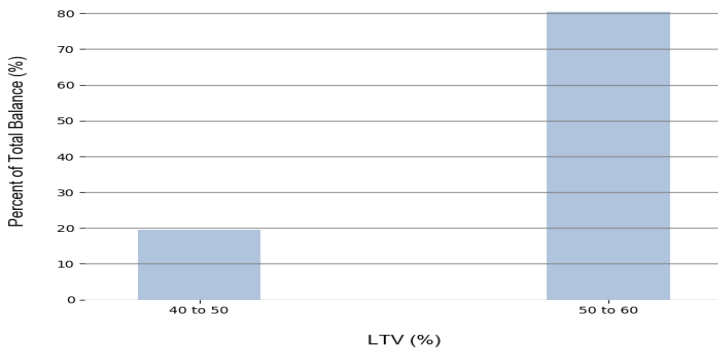
Local Distribution

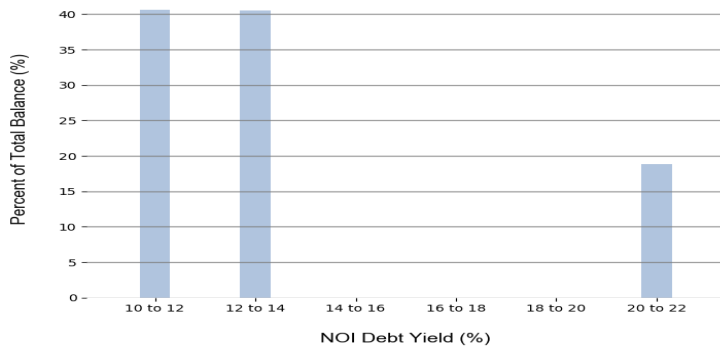

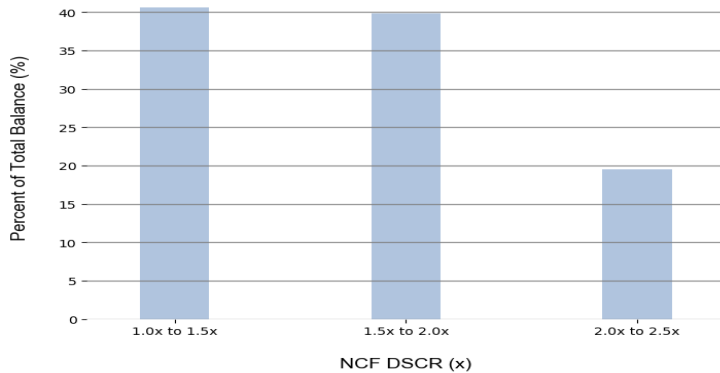
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 10% to 21% with a weighted average NOI debt yield of 14.2%. NOI debt yield ranged from 10% to 21%. There were 2 assets (41% of total balance) with NOI debt yield between 10% and 12%, 2 assets (41% of total balance) with NOI debt yield between 12% and 14%, 1 assets (19% of total balance) with NOI debt yield between 20% and 22%

Net Cash Flow DSCR (x)

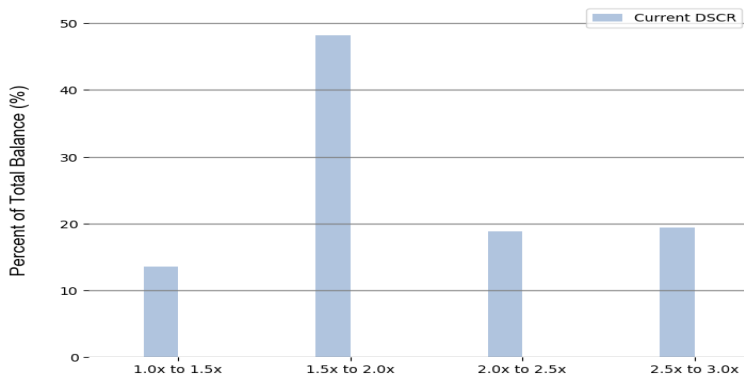


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 2.0x. There were 2 assets (40.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 2 assets (39.9% of total balance) with NCF DSCR between 1.5x and 2.0x and 1 assets (19.5% of total balance) with NCF DSCR between 2.0x and 2.5x. The most recent weighted average NCF DSCR was 1.6x.

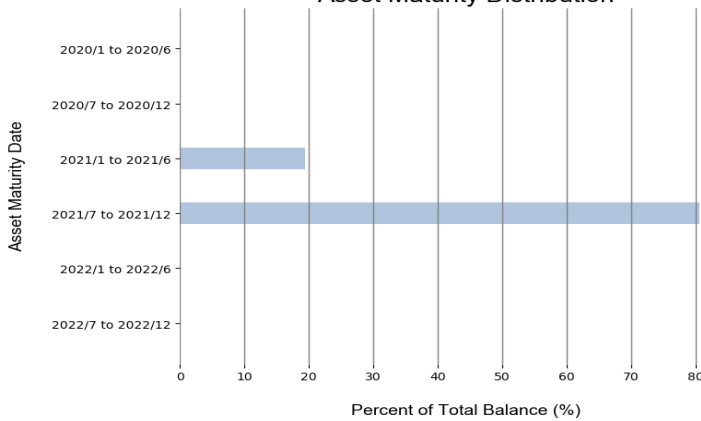
DSCR Distribution (x)



DSCRs ranged from 1.0x to 3.0x. There are 1 assets (13.6% of total balance) with DSCR between 1.0x and 1.5x, 2 assets (48.2% of total balance) with DSCR between 1.5x and 2.0x, 1 assets (18.8% of total balance) with DSCR between 2.0x and 2.5x and 1 assets (19.5% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.9x. Underwritten DSCR is not available.

There are 1 assets (19.5% of total balance) that have maturity dates between 2021/1 and 2021/6 and 4 assets (80.5% of total balance) that have maturity dates between 2021/7 and 2021/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:
