## **Transaction Summary**

The transaction closed on Mar 29 2017 and matures in Apr 2027. The pool's current aggregate principal balance is \$1038.1 million compared to \$1068.7 million at close.

The largest loan of the pool (7.7%) is secured by Hilton Hawaiian Village - Trust located in metropolitan area. Occupancy at the subject was 94%. The second largest loan of the pool (7.7%) is secured by Moffett Gateway located in metropolitan area. Occupancy at the subject was 98%. The largest tenant was Google (97.58%). The third largest loan of the pool (7.1%) is secured by Dallas Design District located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 97%. The major tenants included Work lodge design district LLC (4.29%) and Walter Lee Culp Associates Inc. (4.23%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.64% and 47 months as of 12/15/2020, respectively. There are a total of 40 loans and 55 properties in the portfolio. The appraisal LTV was approximately 56.8% compared to the Original loan to value (LTV), which was approximately 58.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.23x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



Type Concentration











Most recent net operating income debt yield ranged from 6% to 29% with a weighted average NOI debt yield of 12.8%. NOI debt yield ranged from 6% to 29%. There were 1 assets (7% of total balance) with NOI debt yield between 6% and 8%, 12 assets (30% of total balance) with NOI debt yield between 8% and 10%, 12 assets (25% of total balance) with NOI debt yield between 10% and 12%, 6 assets (18% of total balance) with NOI debt yield between 12% and 14%, 4 assets (4% of total balance) with NOI debt yield between 14% and 16%, 2 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (4% of total balance) with NOI debt yield between 20% and 22%, 1 assets (8% of total balance) with NOI debt yield between 22% and 24%, 1 assets (4% of total balance) with NOI debt yield between 28% and 30%

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 5.0x. There were 16 assets (34.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 13 assets (24.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (8.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (13.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (11.4% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (7.7% of total balance) with NCF DSCR between 4.5x and 5.0x. The most recent weighted average NCF DSCR was 2.2x.

Net Cash Flow DSCR (x)





DSCRs ranged from 1.0x to 6.0x. There are 10 assets (16.9% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (34.7% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (15.0% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (8.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (5.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (7.7% of total balance) with DSCR between 3.0x and 4.5x, and 4.0x, 1 assets (3.7% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (7.7% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 2.5x.

There are 2 assets (6.6% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (3.7% of total balance) that have maturity dates between 2023/7 and 2023/12, 7 assets (24.2% of total balance) that have maturity dates between 2026/7 and 2026/12 and 30 assets (65.5% of total balance) that have maturity dates between 2027/1 and 2027/6.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
