Transaction Summary

The transaction closed on Jun 16 2017 and matures in Mar 2037. The pool's current aggregate principal balance is \$658.9 million compared to \$680.7 million at close.

The largest loan of the pool (14.9%) is secured by 245 Park Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included Societe Generale (32.62%) and JPMorgan Chase Bank, National Association (13.08%). The second largest loan of the pool (9.9%) is secured by 211 Main Street - Trust located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Charles Schwab (100.00%). The third largest loan of the pool (6.1%) is secured by 740 Madison located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was Bottega Veneta (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.52% and 59 months as of 03/15/2022, respectively. There are a total of 37 loans and 64 properties in the portfolio. The appraisal LTV was approximately 58.0% compared to the Original loan to value (LTV), which was approximately 59.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.83x. As of 03/15/2022, 7.86% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.





Occupancy Distribution (%)




Local Distribution









There are 5 assets (10.7% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (4.7% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (20.5% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (23.9% of total balance) with DSCR between 1.5x and 2.0x, 4 assets (19.2% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (16.0% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (3.0% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (2.0% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
