Transaction Summary

The transaction closed on Jul 31 2017 and matures in Aug 2027. The pool's current aggregate principal balance is \$797.5 million compared to \$811.1 million at close.

The largest loan of the pool (9.4%) is secured by 245 Park Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included Societe Generale (32.62%) and JPMorgan Chase Bank, National Association (13.08%). The second largest loan of the pool (8.8%) is secured by Gateway Net Lease Portfolio - Trust located in Warren-Troy-Farmington Hills, MI-5.88% Dallas-Plano-Irving, TX-3.91% Detroit-Dearborn-Livonia, MI-3.88% Fort Lauderdale-Pompano Beach-Deerfield Beach, FL-0.65% metropolitan area. Occupancy at the subject was 98%. The major tenants included FedEx (14.28%) and Carrier (9.76%). The third largest loan of the pool (8.2%) is secured by Treeview Industrial Portfolio located in Wilmington, DE-MD-NJ-7.72% Fort Worth-Arlington, TX-6.58% Oakland-Hayward-Berkeley, CA-5.43% metropolitan area. Occupancy at the subject was 96%. The major tenants included Wayfair (16.57%) and Newgistics, Inc. (16.41%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.42% and 40 months as of 10/15/2020, respectively. There are a total of 37 loans and 168 properties in the portfolio. The appraisal LTV was approximately 59.2% compared to the Original loan to value (LTV), which was approximately 59.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.24x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution




NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 17% with a weighted average NOI debt yield of 11.8%. NOI debt yield ranged from 6% to 17%. There were 1 assets (1% of total balance) with NOI debt yield between 6% and 8%, 13 assets (35% of total balance) with NOI debt yield between 8% and 10%, 9 assets (28% of total balance) with NOI debt yield between 10% and 12%, 5 assets (14% of total balance) with NOI debt yield between 12% and 14%, 6 assets (17% of total balance) with NOI debt yield between 14% and 16% and 3 assets (6% of total balance) with NOI debt yield between 14% and 16% and 3 assets (6% of total balance) with NOI debt yield between 16% and 18%.


DSCR (Current / Underwritten)



The most recent weighted average DSCR is 2.5x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
