#### **Transaction Summary**

The transaction closed on Feb 21 2018 and matures in Jan 2023. The pool's current aggregate principal balance is \$200.0 million compared to \$200.0 million at close.

The largest loan of the pool (24.2%) is secured by Beacon - Criterion located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 87%. The second largest loan of the pool (20.8%) is secured by Beacon - Hague located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The third largest loan of the pool (17.6%) is secured by Beacon - Paramount located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 87%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.78% and 52 months as of 05/05/2022, respectively. There are a total of 6 loans and 6 properties in the portfolio. The appraisal LTV was approximately 58.0% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 0.97x. As of 05/05/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.



The 6 properties are all multifamily buildings with a balance of \$200M, which amounted to 100% of total portfolio.



#### Occupancy Distribution (%)










The 6 properties are all in the state of New Jersey with an outstanding balance of \$200M, which amounted to 100% of total portfolio.




#### NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 7% with a weighted average NOI debt yield of 6.2%. NOI debt yield ranged from 4% to 7%. There were 1 assets (21% of total balance) with NOI debt yield between 4% and 5%, 1 assets (24% of total balance) with NOI debt yield between 5% and 6% and 4 assets (55% of total balance) with NOI debt yield between 6% and 7%.

NCF DSCR ranged from 0.5x to 1.5x. There were 3 assets (54.4% of total balance) with NCF DSCR between 0.5x and 1.0x and 3 assets (45.6% of total balance) with NCF DSCR between 1.0x and 1.5x. The most recent weighted average NCF DSCR was 1.0x.







DSCRs ranged from 0.5x to 1.5x.There are 2 assets (45.0% of total balance) with DSCR between 0.5x and 1.0x and 4 assets (55.0% of total balance) with DSCR between 1.0x and 1.5x. The most recent weighted average DSCR is 1.0x.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:
