## **Transaction Summary**

The transaction closed on Jul 06 2018 and matures in Jun 2021. The pool's current aggregate principal balance is \$735.5 million compared to \$1035.0 million at close.

The single asset of the pool is secured by La Quinta Hotel Portfolio which comprised of 235 properties. Occupancy at the subject was 65%.



The weighted average coupon (WAC) and the weighted average age (WALA) were 2.93% and 30 months as of 12/15/2020, respectively. There are a total of 1 loans and 235 properties in the portfolio. The appraisal LTV was approximately 34.3% compared to the Original loan to value (LTV), which was approximately 42.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 3.18x. As of 12/15/2020, 200.00% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 65%.



Occupancy Distribution (%)





Among assets in the portfolio, there are 41 properties (18% of total balance) located in Texas, 42 properties (18% of total balance) in Florida, 18 properties (15% of total balance) in California, 14 properties (8% of total balance) in Colorado, 11 properties (5% of total balance) in Arizona, 9 properties (4% of total balance) in North Carolina, 6 properties (3% of total balance) in Louisiana, 6 properties (3% of total balance) in Georgia, 4 properties (3% of total balance) in South Carolina and 3 properties (3% of total balance) in Washington. Other properties are located in the state of South Carolina, Washington, Illinois, Tennessee, Massachusetts, Nevada, New York, New Mexico, Utah, Maryland, Connecticut, Ohio, Missouri, Virginia, Minnesota, Wisconsin, Arkansas, Vermont, Maine, Michigan, Pennsylvania, Rhode Island, New Hampshire, Oklahoma, Wyoming, New Jersey and Indiana.

Among all the assets in the portfolio, 100% of total balance had LTVs between 30% and 40%.







# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

# 3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

### 4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:
