Transaction Summary

The transaction closed on Feb 28 2019 and matures in Feb 2029. The pool's current aggregate principal balance is \$771.4 million compared to \$774.6 million at close.

The largest loan of the pool (10.0%) is secured by Renaissance Seattle located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 87%. The second largest loan of the pool (9.7%) is secured by 400 South El Camino located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 96%. The major tenants included Alibaba Group (29.17%) and ZS Associates (19.80%). The third largest loan of the pool (8.7%) is secured by Liberty Station Retail located in metropolitan area. Occupancy at the subject was 90%. The major tenants included Vons (15.84%) and STONE BREWING CO LLC (6.88%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.03% and 28 months as of 12/10/2020, respectively. There are a total of 38 loans and 56 properties in the portfolio. The appraisal LTV was approximately 60.6% compared to the Original loan to value (LTV), which was approximately 59.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.71x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.






Local Distribution




NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 15% with a weighted average NOI debt yield of 9.7%. NOI debt yield ranged from 6% to 15%. There were 9 assets (23% of total balance) with NOI debt yield between 6% and 8%, 14 assets (37% of total balance) with NOI debt yield between 8% and 10%, 11 assets (33% of total balance) with NOI debt yield between 10% and 12%, 2 assets (3% of total balance) with NOI debt yield between 12% and 14% and 2 assets (3% of total balance) with NOI debt yield between 14% and 16%.

NCF DSCR ranged from 0.0x to 3.0x. There were 2 assets (1.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (33.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (39.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (23.6% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (1.5% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.7x.







DSCRs ranged from 0.5x to 3.0x.There are 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (24.6% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (34.3% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (39.1% of total balance) with DSCR between 2.0x and 2.5x and 1 assets (1.5% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.8x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
