Transaction Summary

The transaction closed on Feb 28 2019 and matures in Feb 2029. The pool's current aggregate principal balance is \$767.5 million compared to \$774.6 million at close.

The largest loan of the pool (10.0%) is secured by Renaissance Seattle located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 19%. The second largest loan of the pool (9.6%) is secured by 400 South El Camino located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 90%. The major tenants included Alibaba Group U.: (29.17%) and ZS Associates Inc (19.80%). The third largest loan of the pool (8.7%) is secured by Liberty Station Retail located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Vons (15.84%) and LIBERTY PUBLIC MARKET (7.66%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.03% and 43 months as of 03/10/2022, respectively. There are a total of 38 loans and 56 properties in the portfolio. The appraisal LTV was approximately 60.3% compared to the Original loan to value (LTV), which was approximately 59.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.21x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 80%.



Type Concentration












Most recent net operating income debt yield ranged from -2% to 15% with a weighted average NOI debt yield of 6.9%. NOI debt yield ranged from -2% to 15%. There were 2 assets (5% of total balance) with NOI debt yield between -2% and 0%, 4 assets (15% of total balance) with NOI debt yield between 0% and 2%, 2 assets (5% of total balance) with NOI debt yield between 2% and 4%, 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 6 assets (16% of total balance) with NOI debt yield between 6% and 8%, 12 assets (37% of total balance) with NOI debt yield between 8% and 10%, 7 assets (14% of total balance) with NOI debt yield between 10% and 12%, 3 assets (6% of total balance) with NOI debt yield between 12% and 14% and 1 assets (2% of total balance) with NOI debt yield between 14% and 16%.



There were 2 assets (5.4% of total balance) with NCF DSCR between -0.5x and 0.0x, 5 assets (17.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (3.9% of total balance) with NCF DSCR between 0.5x and 1.0x, 9 assets (29.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (36.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 3 assets (5.3% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (2.2% of total balance) with NCF DSCR between 2.5x and 3.0x. 

DSCRs ranged from -0.5x to 3.0x. There are 1 assets (4.3% of total balance) with DSCR between -0.5x and 0.0x, 6 assets (18.9% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (3.9% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (23.6% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (32.6% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (13.0% of total balance) with DSCR between 2.0x and 2.5x and 2 assets (3.7% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.3x.

There are 1 assets (4.8% of total balance) that have maturity dates between 2024/1 and 2024/6, 2 assets (110.0% of total balance) that have maturity dates between 2027/1 and 2027/6, 4 assets (78.4% of total balance) that have maturity dates between 2028/1 and 2028/6, 22 assets (485.2% of total balance) that have maturity dates between 2028/7 and 2028/12 and 9 assets (89.2% of total balance) that have maturity dates between 2029/1 and 2029/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology fo Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
- 3). Do not address whether the expected return of a particular investment is adequate for the inherent risk.

In some cases, the information is limited because of issues such as the lack of reported data. Such shortcomings are not always readily apparent. Factors which affect such projection, and in turn EJR's rating, include changes in the credit worthiness of the collateral assets, changes in the correlation between them, and overall economic changes.
