Transaction Summary

The transaction closed on Mar 31 2017 and matures in Apr 2027. The pool's current aggregate principal balance is \$987.1 million compared to \$1008.6 million at close.

The largest loan of the pool (8.1%) is secured by 229 West 43rd Street Retail Condo located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included Bowlmor Times Square (31.21%) and Times Square Attract (23.80%). The second largest loan of the pool (6.8%) is secured by 350 Park Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included Ziff Brothers Investments, L.L.C. (50.29%) and Manufacturers & Traders Trust Company (17.98%). The third largest loan of the pool (6.5%) is secured by Prudential Plaza located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Tribune Publishing Company LLC (6.04%) and Wilson Sporting Goods Co. (4.04%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.57% and 49 months as of 12/15/2020, respectively. There are a total of 33 loans and 47 properties in the portfolio. The appraisal LTV was approximately 77.3% compared to the Original loan to value (LTV), which was approximately 58.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.16x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 0% to 23% with a weighted average NOI debt yield of 11.6%. NOI debt yield ranged from 0% to 23%. There were 1 assets (3% of total balance) with NOI debt yield between 0% and 2%, 1 assets (8% of total balance) with NOI debt yield between 4% and 6%, 1 assets (6% of total balance) with NOI debt yield between 6% and 8%, 7 assets (18% of total balance) with NOI debt yield between 8% and 10%, 7 assets (17% of total balance) with NOI debt yield between 10% and 12%, 8 assets (28% of total balance) with NOI debt yield between 12% and 14%, 6 assets (13% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (6% of total balance) with NOI debt yield between 22% and 24%

There were 1 assets (2.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 6 assets (22.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (41.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (9.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (3.5% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (6.8% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (4.1% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (3.5% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (6.3% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from 0.0x to 6.0x. There are 1 assets (2.7% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (8.1% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (42.1% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (20.3% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (6.1% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (6.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (4.1% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (3.5% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (6.3% of total balance) with DSCR between 5.5x and 6.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
