## **Transaction Summary**

The transaction closed on Mar 31 2017 and matures in Apr 2027. The pool's current aggregate principal balance is \$986.4 million compared to \$1008.6 million at close.

The largest loan of the pool (8.1%) is secured by 229 West 43rd Street Retail Condo located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included Bowlmor Times Square (31.21%) and Times Square Attract (23.80%). The second largest loan of the pool (6.8%) is secured by 350 Park Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included Ziff Brothers Investments, L.L.C. (50.29%) and Manufacturers & Traders Trust Company (17.98%). The third largest loan of the pool (6.4%) is secured by Prudential Plaza located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Tribune Publishing Company LLC (6.04%) and Wilson Sporting Goods Co. (4.04%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.57% and 50 months as of 01/15/2021, respectively. There are a total of 33 loans and 47 properties in the portfolio. The appraisal LTV was approximately 77.3% compared to the Original loan to value (LTV), which was approximately 58.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.16x. As of 01/15/2021, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





## Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 0% to 23% with a weighted average NOI debt yield of 11.6%. NOI debt yield ranged from 0% to 23%. There were 1 assets (3% of total balance) with NOI debt yield between 0% and 2%, 1 assets (8% of total balance) with NOI debt yield between 4% and 6%, 1 assets (5% of total balance) with NOI debt yield between 6% and 8%, 7 assets (18% of total balance) with NOI debt yield between 8% and 10%, 7 assets (17% of total balance) with NOI debt yield between 10% and 12%, 8 assets (28% of total balance) with NOI debt yield between 12% and 14%, 6 assets (13% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (6% of total balance) with NOI debt yield between 22% and 24%

There were 1 assets (2.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 6 assets (22.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (41.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (9.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (3.5% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (6.8% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (4.1% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (3.5% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (6.3% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from 0.0x to 6.0x. There are 1 assets (2.7% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (8.1% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (42.1% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (20.3% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (6.1% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (6.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (4.1% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (3.5% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (6.3% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 2.3x.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
