Transaction Summary

The transaction closed on Mar 31 2017 and matures in Apr 2027. The pool's current aggregate principal balance is \$906.4 million compared to \$940.0 million at close.

The largest loan of the pool (8.8%) is secured by 229 West 43rd Street Retail Condo located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included Bowlmor Times Square (31.21%) and Times Square Attract (23.80%). The second largest loan of the pool (7.4%) is secured by 350 Park Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 74%. The major tenants included Ziff Brothers Investments, L.L.C. (50.29%) and Manufacturers & Traders Trust Company (17.98%). The third largest loan of the pool (6.9%) is secured by Prudential Plaza located in metropolitan area. Occupancy at the subject was 81%. The major tenants included Wilson Sporting Goods Co. (4.04%) and Opportunity Financial LLC (3.54%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.55% and 65 months as of 04/15/2022, respectively. There are a total of 31 loans and 43 properties in the portfolio. The appraisal LTV was approximately 73.8% compared to the Original loan to value (LTV), which was approximately 58.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.91x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 4% to 27% with a weighted average NOI debt yield of 10.9%. NOI debt yield ranged from 4% to 27%. There were 2 assets (10% of total balance) with NOI debt yield between 4% and 6%, 1 assets (6% of total balance) with NOI debt yield between 6% and 8%, 3 assets (11% of total balance) with NOI debt yield between 8% and 10%, 10 assets (38% of total balance) with NOI debt yield between 10% and 12%, 8 assets (21% of total balance) with NOI debt yield between 12% and 14%, 5 assets (12% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 26% and 28%

NCF DSCR ranged from 0.5x to 4.0x. There were 2 assets (7.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 5 assets (21.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 14 assets (35.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (21.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (6.7% of total balance) with NCF DSCR between 2.5x and 3.0x and 3 assets (8.9% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 1.9x.







DSCRs ranged from 0.5x to 4.0x.There are 1 assets (1.3% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (22.1% of total balance) with DSCR between 1.0x and 1.5x, 13 assets (30.3% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (23.9% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (10.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (2.9% of total balance) with DSCR between 3.0x and 3.5x and 3 assets (8.9% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.0x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
