## **Transaction Summary**

The transaction closed on Oct 16 2018 and matures in Oct 2028. The pool's current aggregate principal balance is \$128.2 million compared to \$133.2 million at close.

The largest loan of the pool (8.0%) is secured by Green Bay Plaza located in metropolitan area. Occupancy at the subject was 88%. The major tenants included TJ Maxx (20.73%) and Big Lots (14.36%). The second largest loan of the pool (6.2%) is secured by Reger Portfolio located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Invista (57.13%) and Icon Idenity Solutions (20.89%). The third largest loan of the pool (6.0%) is secured by Round Top RV MHC located in metropolitan area. Occupancy at the subject was 54%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.27% and 31 months as of 12/15/2020, respectively. There are a total of 31 loans and 40 properties in the portfolio. The appraisal LTV was approximately 60.1% compared to the Original loan to value (LTV), which was approximately 62.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.62x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.



Type Concentration











Most recent net operating income debt yield ranged from 6% to 31% with a weighted average NOI debt yield of 12.2%. NOI debt yield ranged from 6% to 31%. There were 2 assets (5% of total balance) with NOI debt yield between 6% and 8%, 7 assets (24% of total balance) with NOI debt yield between 8% and 10%, 7 assets (21% of total balance) with NOI debt yield between 10% and 12%, 7 assets (27% of total balance) with NOI debt yield between 12% and 14%, 5 assets (17% of total balance) with NOI debt yield between 14% and 16%, 2 assets (4% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 30% and 32%

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 5.0x. There were 13 assets (41.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 14 assets (50.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 3 assets (7.3% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (1.5% of total balance) with NCF DSCR between 4.5x and 5.0x. The most recent weighted average NCF DSCR was 1.6x.





DSCRs ranged from 1.0x to 5.5x. There are 9 assets (29.0% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (50.1% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (16.6% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (2.7% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (1.5% of total balance) with DSCR between 5.0x and 5.5x. The most recent weighted average DSCR is 1.8x.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1a and General Methodology fo Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v1.

# 3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

## 4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:
