Transaction Summary

The transaction closed on Sep 29 2020 and matures in Oct 2030. The pool's current aggregate principal balance is \$263.1 million compared to \$264.2 million at close.

The largest loan of the pool (8.2%) is secured by Reagan Crossing Apartments located in metropolitan area. Occupancy at the subject was 94%. The second largest loan of the pool (7.4%) is secured by Weston South Carolina Industrial Portfolio located in metropolitan area. Occupancy at the subject was 91%. The major tenants included Jushi USA (15.86%) and Husqvarna Consumer Outdoor Products (12.55%). The third largest loan of the pool (6.7%) is secured by Progress Park located in metropolitan area. Occupancy at the subject was 91%. The largest tenant was Progress Park (90.63%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.11% and 8 months as of 10/15/2020, respectively. There are a total of 53 loans and 87 properties in the portfolio. The appraisal LTV was approximately 62.5% compared to the Original loan to value (LTV), which was approximately 62.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.43x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.

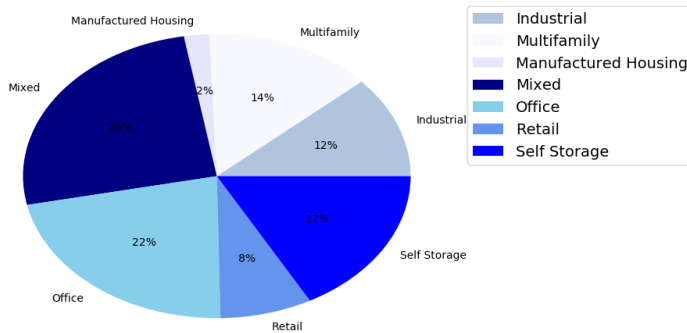

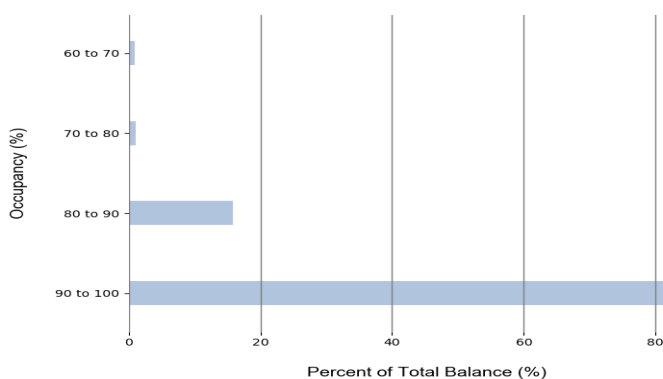

Occupancy Distribution (%)

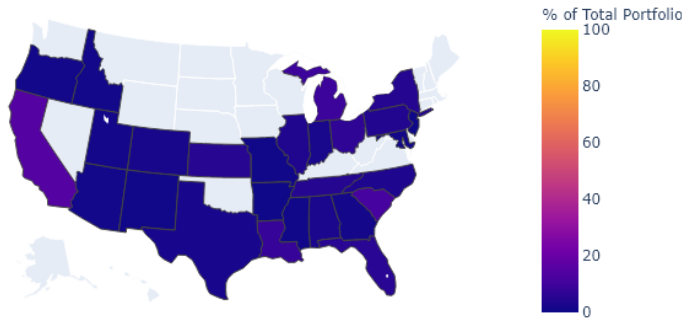

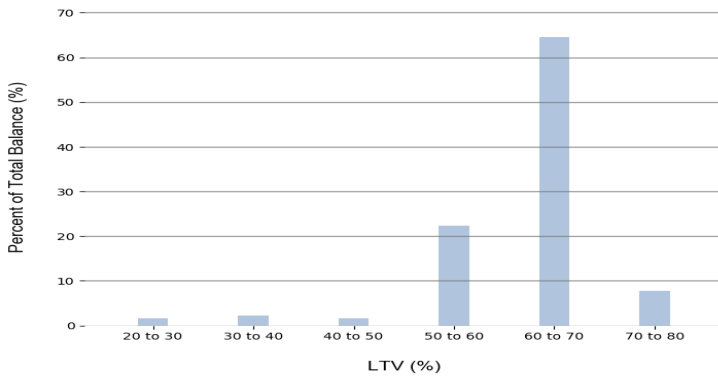
Local Distribution

LTV Distribution (%)



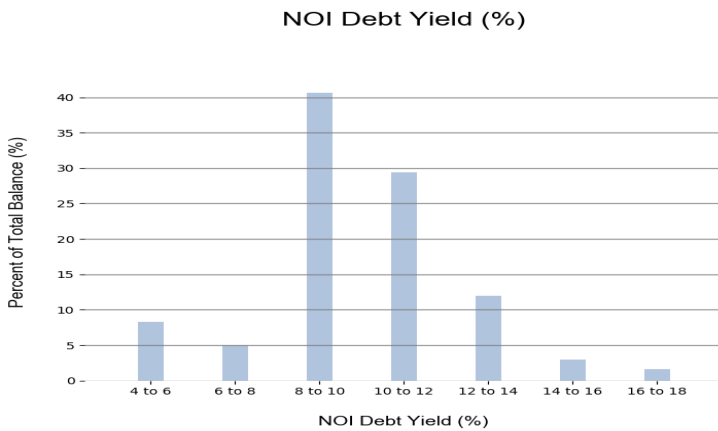

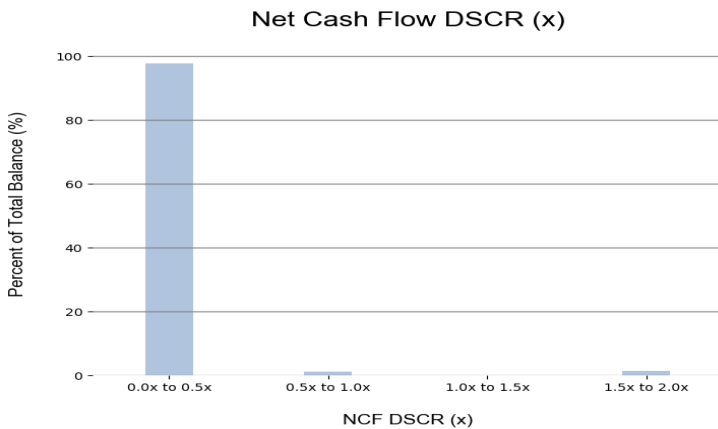

Most recent net operating income debt yield ranged from 4% to 17% with a weighted average NOI debt yield of 9.8%. NOI debt yield ranged from 4% to 17%. There were 3 assets (8% of total balance) with NOI debt yield between 4% and 6%, 6 assets (5% of total balance) with NOI debt yield between 6% and 8%, 18 assets (41% of total balance) with NOI debt yield between 8% and 10%, 12 assets (29% of total balance) with NOI debt yield between 10% and 12%, 9 assets (12% of total balance) with NOI debt yield between 12% and 14%, 3 assets (3% of total balance) with NOI debt yield between 14% and 16% and 2 assets (2% of total balance) with NOI debt yield between 16% and 18%.

NCF DSCR

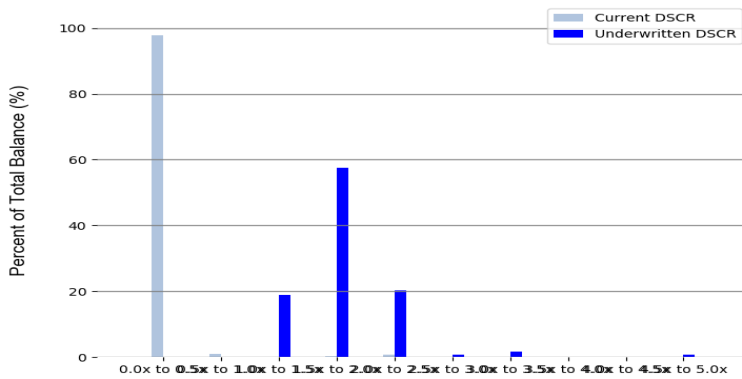

There were 50 assets (97.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (1.0% of total balance) with NCF DSCR between 0.5x and 1.0x and 2 assets (1.2% of total balance) with NCF DSCR between 1.5x and 2.0x. The most recent weighted average NCF DSCR was 1.4x.

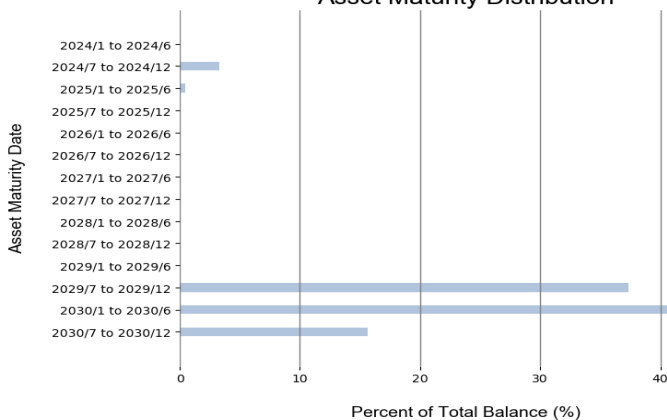
DSCR Distribution (x)



DSCRs ranged from 0.0x to 2.5x. There are 50 assets (97.7% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (1.0% of total balance) with DSCR between 0.5x and 1.0x, 1 assets (0.4% of total balance) with DSCR between 1.5x and 2.0x and 1 assets (0.8% of total balance) with DSCR between 2.0x and 2.5x. The most recent weighted average DSCR is 1.6x.

There are 3 assets (3.3% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (0.4% of total balance) that have maturity dates between 2025/1 and 2025/6, 21 assets (37.3% of total balance) that have maturity dates between 2029/7 and 2029/12, 23 assets (43.2% of total balance) that have maturity dates between 2030/1 and 2030/6 and 5 assets (15.6% of total balance) that have maturity dates between 2030/7 and 2030/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
