Transaction Summary

The transaction closed on Sep 29 2020 and matures in Oct 2030. The pool's current aggregate principal balance is \$255.7 million compared to \$261.9 million at close.

The largest loan of the pool (8.4%) is secured by Reagan Crossing Apartments located in metropolitan area. Occupancy at the subject was 98%. The second largest loan of the pool (7.6%) is secured by Weston South Carolina Industrial Portfolio located in metropolitan area. Occupancy at the subject was 91%. The major tenants included HUSQVARNA Consumer OutDC (12.56%) and Jushi USA Fiberglass Co. LTD. (11.04%). The third largest loan of the pool (6.9%) is secured by Progress Park located in metropolitan area. Occupancy at the subject was 100%. The major tenants included G&J Pepsi Cola Bottles Inc (16.67%) and Hearthside Food Solutions (16.67%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.10% and 26 months as of 04/15/2022, respectively. There are a total of 52 loans and 86 properties in the portfolio. The appraisal LTV was approximately 61.4% compared to the Original loan to value (LTV), which was approximately 62.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.13x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 95%.

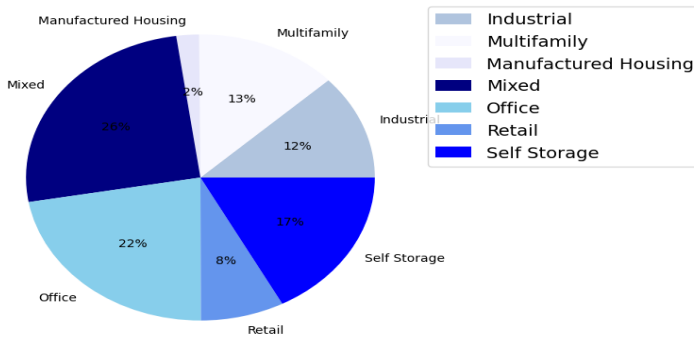

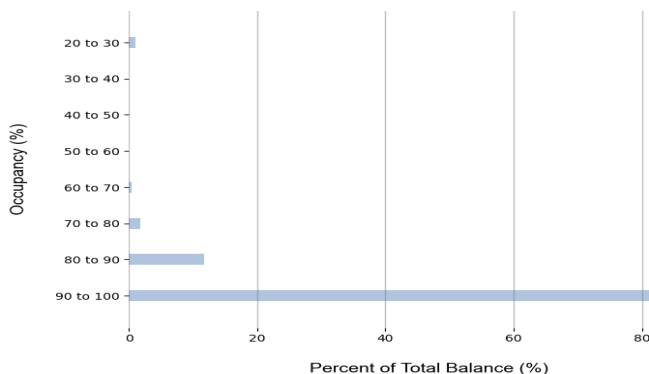

Occupancy Distribution (%)

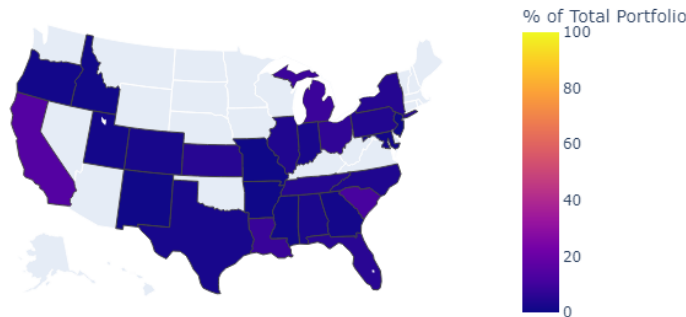

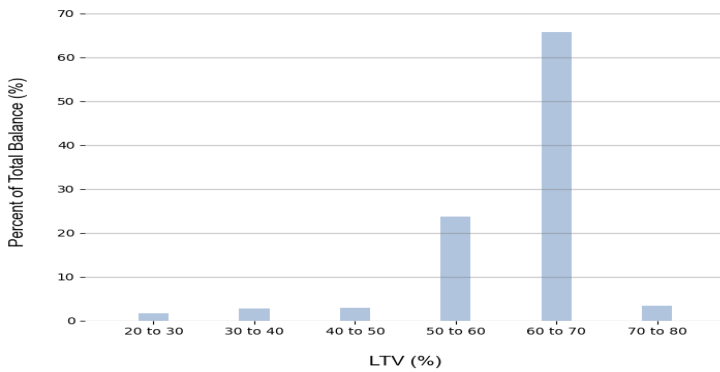
Local Distribution

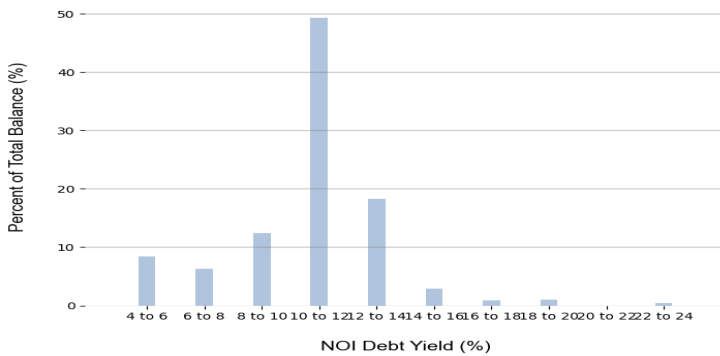

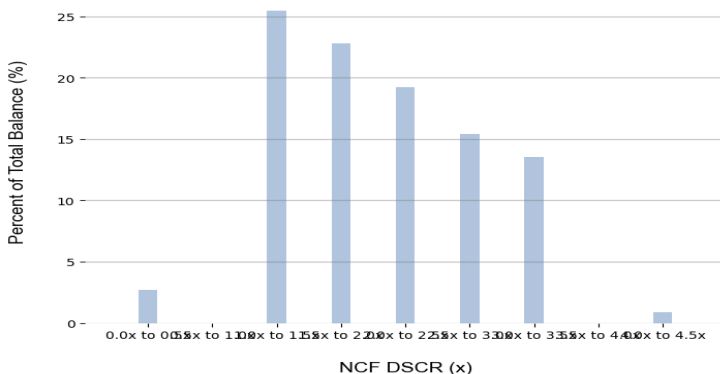
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

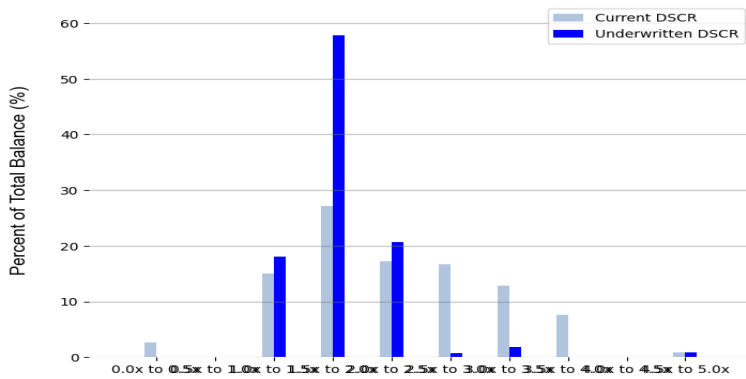

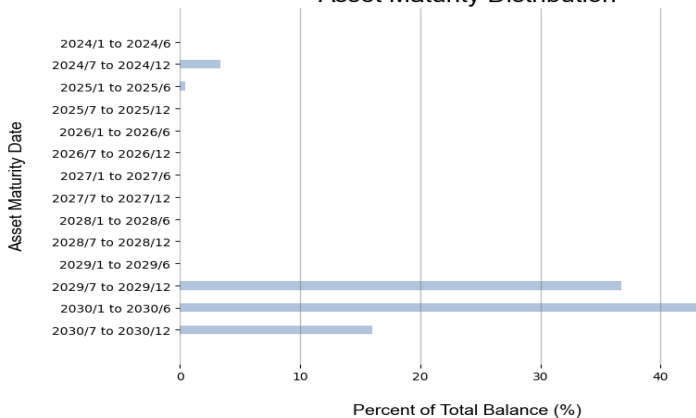
DSCR Distribution (x)

There are 3 assets (2.7% of total balance) with DSCR between 0.0x and 0.5x, 7 assets (15.0% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (27.1% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (17.3% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (16.7% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (12.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (7.6% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.9% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.3x.

There are 3 assets (8.7% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (1.1% of total balance) that have maturity dates between 2025/1 and 2025/6, 20 assets (93.9% of total balance) that have maturity dates between 2029/7 and 2029/12, 23 assets (111.0% of total balance) that have maturity dates between 2030/1 and 2030/6 and 5 assets (40.9% of total balance) that have maturity dates between 2030/7 and 2030/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

Appendix I

Smoothing Calculation
