#### Transaction Summary

The transaction closed on Jun 29 2017 and matures in Jul 2037. The pool's current aggregate principal balance is \$584.6 million compared to \$601.1 million at close.

The largest loan of the pool (10.0%) is secured by Marriott LAX located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 91%. The second largest loan of the pool (9.4%) is secured by Two Riverfront Plaza located in Newark, NJ-PA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Panasonic Corp of North America (100.00%). The third largest loan of the pool (8.9%) is secured by Bank of America Office Campus Buildings 200 - 500 located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Bank Of America (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.81% and 44 months as of 12/10/2020, respectively. There are a total of 56 loans and 68 properties in the portfolio. The appraisal LTV was approximately 59.5% compared to the Original loan to value (LTV), which was approximately 60.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.64x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





## Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 2% to 25% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 2% to 25%. There were 1 assets (0.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 12 assets (27.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 38 assets (58.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 3 assets (11.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (1.0% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.8% of total balance) with NCF DSCR between 3.5x and 4.0x. 



# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
