Transaction Summary

The transaction closed on Jun 29 2017 and matures in Jul 2037. The pool's current aggregate principal balance is \$509.9 million compared to \$534.1 million at close.

The largest loan of the pool (11.2%) is secured by Marriott LAX located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 65%. The second largest loan of the pool (10.3%) is secured by Bank of America Office Campus Buildings 200 - 500 located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Bank Of America (100.00%). The third largest loan of the pool (9.2%) is secured by Peoples Center located in metropolitan area. Occupancy at the subject was 90%. The major tenants included Peoples Natural Gas Company LLC (62.80%) and AT&T (6.99%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.96% and 59 months as of 04/10/2022, respectively. There are a total of 54 loans and 66 properties in the portfolio. The appraisal LTV was approximately 66.2% compared to the Original loan to value (LTV), which was approximately 64.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.28x. As of 04/10/2022, 3.43% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.





Occupancy Distribution (%)




Local Distribution





There were 2 assets (8% of total balance) with NOI debt yield between 0% and 2%, 3 assets (6% of total balance) with NOI debt yield between 2% and 4%, 2 assets (12% of total balance) with NOI debt yield between 4% and $6\%,\,1$ assets (3% of total balance) with NOI debt yield between 6% and 8%, 30 assets (39% of total balance) with NOI debt yield between 8% and 10%, 6 assets (10% of total balance) with NOI debt yield between 10% and 12%, 7 assets (18% of total balance) with NOI debt yield between 12% and 14%, 1 assets (3% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 20% and 22%

There were 3 assets (8.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (14.9% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (22.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 33 assets (52.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 2 assets (1.0% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (0.9% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 1.3x.







DSCRs ranged from 0.0x to 4.0x.There are 3 assets (8.5% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (14.9% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (17.7% of total balance) with DSCR between 1.0x and 1.5x, 34 assets (53.7% of total balance) with DSCR between 1.5x and 2.0x, 4 assets (4.4% of total balance) with DSCR between 2.0x and 2.5x and 1 assets (0.9% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.4x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
