Transaction Summary

The transaction closed on Mar 31 2017 and matures in Mar 2027. The pool's current aggregate principal balance is \$640.5 million compared to \$650.0 million at close.

The largest loan of the pool (10.9%) is secured by Charlotte Plaza located in metropolitan area. Occupancy at the subject was 81%. The major tenants included Lowe's Home Improvement (31.75%) and Grant Thornton (8.85%). The second largest loan of the pool (9.4%) is secured by Hotel Gansevoort located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The third largest loan of the pool (8.1%) is secured by Greenwich Financial Center located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Morgan Stanley (30.97%) and Balyasny Asset Management LP (17.96%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.74% and 50 months as of 12/10/2020, respectively. There are a total of 25 loans and 28 properties in the portfolio. The appraisal LTV was approximately 63.7% compared to the Original loan to value (LTV), which was approximately 64.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.48x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



Type Concentration






Local Distribution

Among assets in the portfolio, there are 6 properties (22% of total balance) located in California, 2 properties (17% of total balance) in New York, 2 properties (14% of total balance) in North Carolina, 5 properties (11% of total balance) in Texas, 1 property (8% of total balance) in Connecticut and 2 properties (7% of total balance) in New Jersey. Other properties are located in the state of Alabama, Mississippi, Illinois and Colorado.








Most recent net operating income debt yield ranged from 6% to 19% with a weighted average NOI debt yield of 8.3%. NOI debt yield ranged from 6% to 19%. There were 8 assets (52% of total balance) with NOI debt yield between 6% and 8%, 12 assets (36% of total balance) with NOI debt yield between 8% and 10%, 3 assets (7% of total balance) with NOI debt yield between 10% and 12%, 1 assets (4% of total balance) with NOI debt yield between 12% and 14%, 1 assets (2% of total balance) with NOI debt yield between 18% and 20%

NCF DSCR




Net Cash Flow DSCR (x)

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 3.0x. There were 13 assets (61.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 9 assets (29.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 1 assets (3.5% of total balance) with NCF DSCR between 2.0x and 2.5x and 2 assets (5.5% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.5x.



DSCRs ranged from 1.0x to 3.0x.There are 12 assets (60.1% of total balance) with DSCR between 1.0x and 1.5x, 7 assets (19.3% of total balance) with DSCR between 1.5x and 2.0x, 4 assets (15.0% of total balance) with DSCR between 2.0x and 2.5x and 2 assets (5.5% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.6x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
