Transaction Summary

The transaction closed on Mar 31 2017 and matures in Mar 2027. The pool's current aggregate principal balance is \$545.0 million compared to \$558.4 million at close.

The largest loan of the pool (12.8%) is secured by Charlotte Plaza located in metropolitan area. Occupancy at the subject was 70%. The major tenants included Lowe's Home Improvement (31.75%) and PIPER SANDLER & CO. (4.14%). The second largest loan of the pool (11.0%) is secured by Hotel Gansevoort located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The third largest loan of the pool (9.4%) is secured by Greenwich Financial Center located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Morgan Stanley (30.97%) and Balyasny Asset Management LP (24.63%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.70% and 65 months as of 03/10/2022, respectively. There are a total of 20 loans and 23 properties in the portfolio. The appraisal LTV was approximately 62.0% compared to the Original loan to value (LTV), which was approximately 62.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.39x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.






Local Distribution








Most recent net operating income debt yield ranged from -4% to 23% with a weighted average NOI debt yield of 8.2%. NOI debt yield ranged from -4% to 23%. There were 1 assets (8% of total balance) with NOI debt yield between -4% and -2%, 6 assets (36% of total balance) with NOI debt yield between 6% and 8%, 6 assets (27% of total balance) with NOI debt yield between 8% and 10%, 4 assets (20% of total balance) with NOI debt yield between 10% and 12%, 1 assets (1% of total balance) with NOI debt yield between 12% and 14%, 1 assets (2% of total balance) with NOI debt yield between 16% and 18%, 1 assets (6% of total balance) with NOI debt yield between 22% and 24%



DSCR (Current / Underwritten)



DSCRs ranged from -0.5x to 3.0x.There are 1 assets (7.9% of total balance) with DSCR between -0.5x and 0.0x, 9 assets (50.6% of total balance) with DSCR between 1.0x and 1.5x, 6 assets (16.8% of total balance) with DSCR between 1.5x and 2.0x, 3 assets (19.2% of total balance) with DSCR between 2.0x and 2.5x and 1 assets (5.5% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.5x.

There are 1 assets (70.0% of total balance) that have maturity dates between 2023/1 and 2023/6, 1 assets (15.8% of total balance) that have maturity dates between 2023/7 and 2023/12, 1 assets (12.4% of total balance) that have maturity dates between 2025/1 and 2025/6, 6 assets (142.0% of total balance) that have maturity dates between 2026/1 and 2026/6, 3 assets (50.8% of total balance) that have maturity dates between 2026/7 and 2026/12 and 8 assets (254.0% of total balance) that have maturity dates between 2027/1 and 2027/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
